## WYSIGINGSWET OP HUWELIKSAANGELEENTHEDE, 1976

**WET**

**Tot wysiging van die Wet op Huweliksaangeleenthede, 1953, ten einde die aanspreeklikheid van gades buite gemeenskap van goed getroud vir huishoudelike benodigdhede verder te reël; en om vir bykomstige aangeleenthede voorsiening te maak.**

**DAAR WORD BEPAAL** deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Vervanging van artikel 3 van Wet 37 van 1953.

**1.** Artikel 3 van die Wet op Huweliksaangeleenthede, 1953, word hierby deur die volgende artikel vervang:

„Aanspreeklikheid van gades vir huishoudelike benodigdhede.

**3.** (1) Gades buite gemeenskap van goed getroud, is teenoor derdes gesamentlik en afsonderlik aanspreeklik vir alle skulde wat deur die een of die ander van hulle ten opsigte van benodigdhede vir die gesamentlike huishouding aangegaan is.

(2) 'n Gade buite gemeenskap van goed getroud, is verplig om ten opsigte van benodigdhede vir die gesamentlike huishouding *pro rata* volgens sy of haar inkomste by te dra.

(3) 'n Gade buite gemeenskap van goed getroud, het, vir sover hy of sy ten opsigte van benodigdhede vir die gesamentlike huishouding meer bygedra het as by subartikel (2) bepaal, 'n reg van verhaal op die ander gade.”.

## MATRIMONIAL AFFAIRS AMENDMENT ACT, 1976

Act No. 13, 1976

# ACT

To amend the Matrimonial Affairs Act, 1953, so as to further regulate the liability of spouses married out of community of property for household necessaries; and to provide for incidental matters.

*(English text signed by the State President.)  
(Assented to 8 March 1976.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. The following section is hereby substituted for section 3 of the Matrimonial Affairs Act, 1953: Substitution of section 3 of Act 37 of 1953.

“Liability of spouses for household necessities. 3. (1) Spouses married out of community of property shall against third parties be liable jointly and severally for all debts incurred by either of them in respect of the necessaries for the joint household.

(2) A spouse married out of community of property shall be liable to contribute *pro rata* according to his or her income in respect of necessities for the joint household.

(3) A spouse married out of community of property shall have a right of recourse against the other spouse in so far as he or she has contributed more in respect of necessities for the joint household than is provided by subsection (2).”.

2. This Act shall be called the Matrimonial Affairs Amendment Act, 1976. Short title.
