

MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944): APPOINTMENT OF A PLACE FOR THE HOLDING OF A COURT FOR SUCH DISTRICT

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, acting under section 2(1)(h) and (l) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), hereby with effect from 1 March 2019 –

- (a) Withdraw Government Notice No. 113/16 published in Government Gazette No. 2281 of 14 June 1935, appointing Formosa as a place for the holding of a periodical court for the district of Knysna;
- (b) Appoint Plettenberg Bay court located at Corner N2 and Saringa Way, New Horizons, Plettenberg Bay, as a place for the holding of a court for Knysna magisterial district to serve the Bitou Municipality; and
- (c) Prescribe the local limits of the district of Knysna as the local limits within which the said court shall have jurisdiction.

MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944): APPOINTMENT OF A PLACE FOR THE HOLDING OF A COURT FOR SUCH DISTRICT

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, acting under section 2(1)(h) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), hereby with effect from 1 March 2019 –

- (a) Amend Government Notice No. 962 published in the Government Gazette No. 38268 of 28 November 2014, by deleting Booyens under Column "C" of the Schedule to the Notice;
- (b) Appoint Booyens court located at Erf 203, Amanda Avenue and Riffle Road, Oakdene, as a place for the holding of a court for the Johannesburg Central Magisterial District; and
- (c) Prescribe the local limits of the district of Johannesburg Central as the local limits within which the said court shall have jurisdiction.
