

AMENDMENT OF DIRECTIONS ON THE RISK-ADJUSTED STRATEGY FOR THE COMMUNICATIONS AND DIGITAL TECHNOLOGIES SECTOR ISSUED UNDER REGULATION 4(10) OF THE REGULATIONS MADE UNDER SECTION 27(2) OF THE DISASTER MANAGEMENT ACT, 2002 (ACT NO. 57 OF 2002)

I, Jackson Mthembu, Acting Minister of Communications and Digital Technologies, hereby, under regulation 4(10) of the Regulations made under section 27(2) of the Disaster Management Act, 2002 (Act No. 57 of 2002), and published in Government Notice No. R480, Government Gazette No. 43258 of 29 April 2020, amend the Directions on the Risk-Adjusted Strategy for the Communications and Digital Technologies Sector published in Government Gazette No. 43263, Government Notice No. 484 of 3 May 2020, as indicated in the Schedule.

SCHEDULE

DEFINITION

1. In this Schedule “the Directions” means the Directions on the Risk-Adjusted Strategy for the Communications and Digital Technologies Sector published in *Government Gazette* No. 43263, Government Notice No. 484 of 3 May 2020.

AMENDMENT OF PARAGRAPH 3 OF DIRECTIONS

2. Paragraph 3 of the Directions is hereby amended by the deletion in column 2 of the table in paragraph 3.2 of the following:

“Additional measures for Post Office/ Postbank branches:

In addition to the requirements of Regulation 28(2) the following mitigation measures apply:

- Not more than 30% of staff must be allowed to enter the workplace at the same time at any point;
- Different start and end times should be implemented;
- No more that 882 (almost 60%) of Post Office branches may be open.”

COMMENCEMENT

3. These Directions come into operation on the date of publication in the *Government Gazette*.
