PROCLAMATION

by the Premier

of the

Province of the Eastern Cape

No. 3, 1996

COMMISSION OF INQUIRY INTO MATTERS RELATING TO STATE PROPERTY AND OTHER PROPERTY IN THE PROVINCE OF THE EASTERN CAPE: FURTHER AMENDMENT TO PROCLAMATION No. 15 OF 1995, AS AMENDED BY PROCLAMATION No. 24 OF 1995

Under the powers vested in me by section 1 of the Provincial Commissions Act, 1994 (Act No. 3 of 1994), I hereby-

- (a) amend Proclamation No. 15 of 1995, as follows:
 - (i) By the substitution in the portion of the Proclamation preceding the Schedule thereto for the expression "together with those of section 415 (2), (3) and (5) and section 417 (2) (b) and (3) of the Companies Act, 1973 (Act No. 61 of 1973), together with those of section 67 (1) of the Insolvency Act, 1936 (Act No. 24 of 1936)" of the expression "together with those of the Commissions Act, 1947 (Act No. 8 of 1947)";

- (ii) by the insertion after regulation 15 of the following regulation:
 - "15A. (1) Any person or party against, or in respect of, whom the Commission has made a finding or issued an order by virtue, or in terms, of the provisions of regulation 14 (1) or (2) or regulation 15 (1) or (2) may, subject to subregulations (2), (3) and (4), appeal to the relevant division of the Supreme Court of South Africa or to the Constitutional Court against such finding or order.
 - (2) No such appeal shall be lodged unless the Chairperson has granted leave to appeal in favour of the person or party intending to lodge such an appeal.
 - (3) (a) The laws, rules or principles regulating appeals from a single judge of the Supreme Court to the full bench of the Supreme Court or to the Appellate Division of the Supreme Court or to the Constitutional Court shall mutatis mutandis apply in respect of an appeal contemplated in this regulation.
 - (b) The Chairperson shall prescribe the procedure to be applied in respect of an application for leave to appeal contemplated in subregulation (2).
 - (4) Any finding or order in respect of which an appeal is pending shall, pending the finalisation of the appeal, not be executed unless the Chairperson has, on application by an interested party, directed or ruled otherwise."; and
- (b) determine that the amendments set out in paragraph (a) shall be deemed to have come into operation on 14 June 1995.

DISSOLUTION OF BOARDS OF DIRECTORS OF THE TRANSKEI DEVELOPMENT CORPORATION, CISKEI PEOPLE'S DEVELOPMENT BANK AND CISKEI SMALL BUSINESS CORPORATION, APPOINTMENT OF A TRANSITIONAL BOARD IN RESPECT OF THE THREE CORPORATIONS AND OTHER INCIDENTAL MATTERS

Under the powers vested in me by section 24 of the Corporations Transitional Provisions Act, 1995 (Act No. 12 of 1995), I, Raymond Mphakamisi Mhlaba, Premier of the Province of the Eastern Cape, hereby, with effect from the date of publication hereof—

- (a) terminate the appointment of the current members of the boards of directors of the-
 - (i) Transkei Development Corporation;
 - (ii) Ciskei People's Development Bank; and
 - (iii) Ciskei Small Business Corporation; and
- (b) declare that—
 - (i) the existing boards of the above-mentioned corporations are hereby dissolved;
 - (ii) a new board replacing the said boards, and to be known as the Eastern Cape Development Agencies Board, is established; and
 - (iii) the new board shall consist of the following members:
