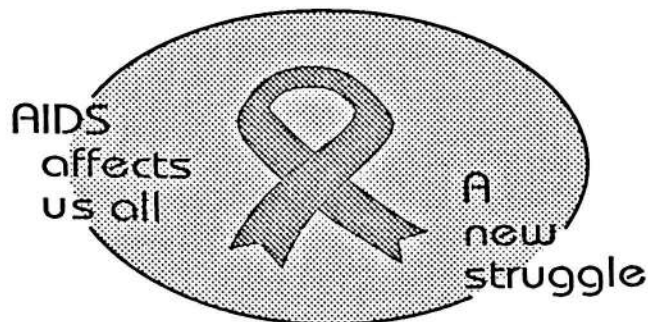

ADVERTISING ON ROADS AND RIBBON DEVELOPMENT ACT, 1940 (ACT No. 21 OF 1940)

WITHDRAWAL OF RESTRICTIONS ON ERECTION OF SECURITY (BOOM) GATES AND AUTHORISATION OF ERECTION OF SUCH GATES AT ABERDEEN AND ALEXANDRIA, AND GENERAL NOTIFICATION OF MEMBERS OF THE PUBLIC IN RESPECT OF OTHER AREAS IN THE PROVINCE

I, Makhenkesi Arnold Stofile, Premier of the Province of the Eastern Cape, acting in terms of section 7, read with section 9 of the Advertising on Roads and Ribbon Development Act, 1940 (Act No. 21 of 1940), and after taking into account comments submitted by stakeholders and members of the public in the public hearings conducted in the respective areas—

1. hereby withdraw any restriction previously imposed in terms of these provisions on the erection of security (boom) gates on any proclaimed road traversing farming areas in the Districts of Aberdeen and Alexandria;
2. direct that any person who intends erecting a security (boom) gate on any proclaimed road at Aberdeen and Alexandria must apply to the Member of the Executive Council responsible for Transport in the Province for a written permission;
3. the responsible Member shall determine conditions upon which erection of security (boom) gates may be granted taking into account, *inter alia*, inputs received during public hearings in the affected area; and
4. Members of the public are hereby notified that in respect of the other areas in the Province where communities or members thereof want to erect security (boom) gates in their respective areas, they must submit an application, in writing, to the Member of the Executive Council responsible for Transport, whereupon he or she shall cause the holding of public hearings in the affected area prior to his or her consideration of such application: Provided that the responsible Member may, on granting of the application, impose any conditions as he or she considers appropriate;
5. direct that applications may be addressed to the Head of Department, Private Bag X0023, Department of Transport, Bisho, 5605.

ACT

To appropriate an additional amount of money for the requirements of the Province of the Eastern Cape for the financial year ending 31 March 2002

(English text signed by the Premier)

(Assented to on 5 February 2002)

BE IT ENACTED by the Legislature of the Province of the Eastern Cape, as follows—

Appropriation of additional amount of money for requirements of the Province of the Eastern Cape

1. Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), there is hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province of the Eastern Cape in respect of the financial year ending 31 March 2002, as a charge to the Revenue Account, an additional amount of R1 517 524 (one billion five hundred and seventeen million five hundred and twenty four thousand rands), in accordance with the Schedule hereto.

Short title

2. This Act is called the Adjustments Appropriation Act, 2001 (Eastern Cape).
