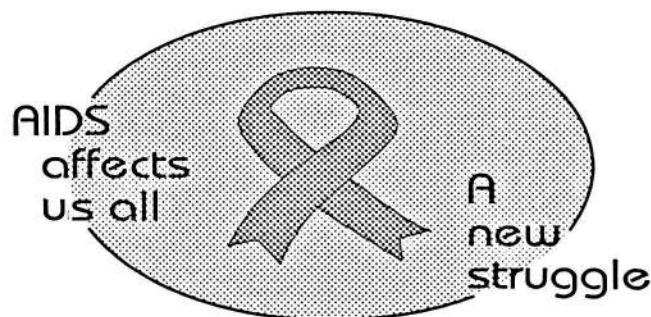

No. 2 of 2002 (E.C.): Second Adjustment Appropriation Act, 2002 (Eastern Cape)

ACT

To appropriate an additional amount of money for the requirements of the Province of the Eastern Cape for the financial year ending 31 March 2002.

BE IT ENACTED by the Legislature of the Province of the Eastern Cape, as follows:-

Appropriation of an additional amounts of money for the requirements of the Province of the Eastern Cape

1. Subject to the provisions of the Public Finance Management Act, 1999 (Act No 1 of 1999), there is hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province of the Eastern Cape in respect of the financial year ending 31 March 2002, as a charge to the Revenue Account, the additional amount of R831 034 000 (Eight hundred & thirty one million thirty four thousand rands) shown in the Schedule hereto.

Short title

2. This Act is called the Second Adjustments Appropriation Act, 2002 (Eastern Cape).

It is hereby notified that the Premier has assented to the following Act which is hereby published for general information:

No. 1 of 2002 (E.C.): Interim Appropriation Act, 2002 (Eastern Cape)

ACT

To appropriate money for the interim requirements of the Province of the Eastern Cape in respect of the first four months of a financial year if an annual budget is not passed before the start of that financial year.

(Assented to on 17 June 2002)

BE IT ENACTED by the Legislature of the Province of the Eastern Cape as follows:-

Appropriation of money for the interim requirements of the Province of the Eastern Cape

1. (a) Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), there is hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province of the Eastern Cape, in respect of the financial year for which an annual budget is not passed as a direct charge against the Provincial Revenue Account –
 - (i) in respect of the first four months of the financial year for which an annual budget is not passed not more than 45 percent of the total amount appropriated in the previous annual budget;
 - (ii) during each of the following months, not more than 10 percent of the total amount appropriated in the previous annual budget; and
 - (iii) in aggregate not more than the total amount appropriated in the previous annual budget.
- (b) The funds appropriated in terms of this Act are not additional to funds appropriated for the relevant financial year and any funds withdrawn in terms of this Act must be regarded as forming part of the funds appropriated in the relevant annual budget for that financial year.

Short title

2. This Act is called the Interim Appropriation Act, 2002 (Eastern Cape).
