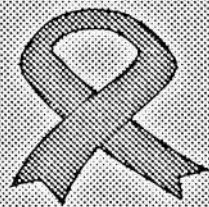

**AGRICULTURAL DEVELOPMENT ACT, 1999 (ACT NO. 8 OF 1999)****INTENTION TO ESTABLISH AN ADVISORY COMMITTEE IN TERMS OF SECTION 3 (4)**

I, Maxwell Mutile Mamase, Member of the Executive Council, responsible for Agriculture in the Province of the Eastern Cape, acting in terms of section 3 (4) of the Agricultural Development Act, 1999 (Act No. 8 of 1999), hereby give notice of my intention to establish an advisory committee, its intended purpose, composition, functions and duration, as well as the procedure for the selection and appointment of its members, as set out in the schedule hereto.

**M. M. MAMASE, Member of the Executive Council****SCHEDULE****PURPOSE OF ADVISORY COMMITTEE**

1. The purpose of the Advisory Committee is to advise the MEC on the matters relating to agricultural development for the Province of the Eastern Cape.

**COMPOSITION OF THE COMMITTEE**

2. The Advisory Committee shall be composed of thirteen members selected and appointed in accordance with paragraph 3.

**PROCEDURE FOR SELECTION AND APPOINTMENT**

3. (1) Members of the Advisory Committee shall be selected by stakeholders or interest groups from persons who have knowledge and experience in Agriculture.

(2) The MEC shall appoint thirteen members of the Advisory Committee referred to in paragraph 2 from the persons selected by the stakeholders or interest groups contemplated in sub paragraph (1).

**DURATION OF THE ADVISORY COMMITTEE**

4. The Advisory Committee members shall be appointed to serve for a period of twelve months.

**FUNCTIONS**

5. (1) The Advisory Committee shall, either at its own instance or at the request of the MEC, advise the MEC on any matter connected with the exercise of his or her powers and the performance of his or her functions and duties.

(2) The Committee must report on its activities to the MEC every three months of its duration.
