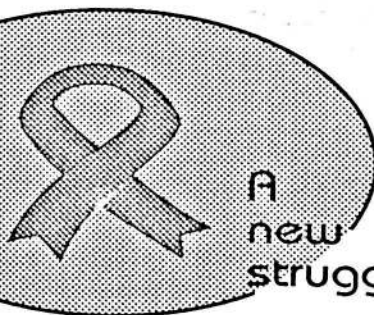

Short title
