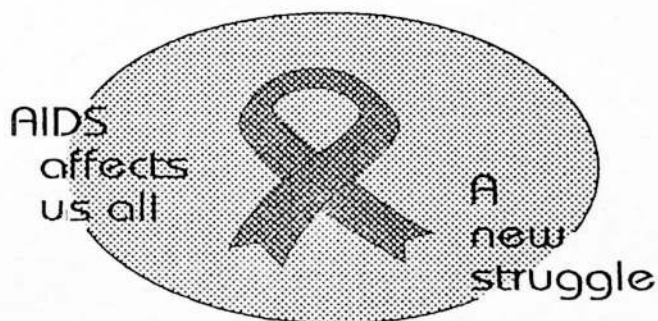

ACT NO 6 OF 2004 (EC) PROVINCIAL TENDER BOARD REPEAL ACT, 2004 (EASTERN CAPE)

ACT

To provide for the repeal of the Provincial Tender Board Act, 1994(Eastern Cape); to provide for a transition; to provide for the matters incidental thereto.

(Assented to on 15-12-2004)*

BE IT ENACTED by the Legislature of the Province of the Eastern Cape, as follows:-

REPEAL OF ACT 2 OF 1994

1. The Provincial Tender Board Act, 1994(Act No.2 of 1994), together with the Tender Board Regulations published in Provincial Notice No.13 of 1995, is hereby repealed as a whole.

TRANSITION

2. (1) All acts done in terms of the laws repealed in section 1 must be dealt with and completed in terms of the relevant provisions of such laws as if such laws have not been repealed.
- (2) The procurement of goods and services for all Provincial departments and provincial public entities must, from the date of commencement of this Act, be done in accordance with Eastern Cape Provincial Treasury Supply Chain Management Instructions issued by the Member of the Executive Council responsible for finance in the Province in terms of section 18 (2) of the Public Finance Management Act, 1999 (Act No.1 of 1999).
- (3) The Technical Review Committee established in terms of the Provincial Treasury Supply Chain Management Instructions is a successor in title in respect of acts or matters which have not been completed as contemplated in subsection (1).
- (4) In dealing with acts or matters which have not been completed as contemplated in subsection (1), the Technical Review Committee must exercise such powers and perform such functions as exercised and performed by the Provincial Tender Board in terms of laws repealed in terms of section 1.

SHORT TITLE

3. This Act is called the Provincial Tender Board Repeal Act, 2004 (Eastern Cape).

ACT NO 3 OF 2004 (EC) ADJUSTMENTS APPROPRIATION ACT, 2004 (EASTERN CAPE)

ACT

To appropriate an additional amount of money for the requirements of the Province of the Eastern Cape for the financial year ending 31 March 2005; and to provide for matters incidental thereto.

(Assented to on 15-12-2004)

BE IT ENACTED by the Legislature of the Province of the Eastern Cape, as follows:-

Appropriation of an additional amount of money for the requirements of the Province of the Eastern Cape

1. Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), there is hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province of the Eastern Cape in respect of the financial year ending 31 March 2005, as a charge to the Revenue Fund, an additional amount of R128, 489, 000 (One hundred and twenty eight million four hundred and eighty nine thousand rands), as indicated in the Schedule hereto.

Short title

2. This Act is called the Adjustments Appropriation Act, 2004 (Eastern Cape).
