

PROVINCIAL GAZETTE No. 1496 DATED 06 MARCH 2006 THAT SEEKS TO AMEND PROVINCIAL GAZETTE NO. 687 DATED 2 DECEMBER 2000, ISSUED IN TERMS OF SECTION 12 OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (ACT NO. 117 OF 1998), AS AMENDED, IS HEREBY CORRECTED

I, **SAM KWELITA**, Member of the Executive Council responsible for local government in the Province of the Eastern Cape, hereby withdraw provisions of Provincial Gazette No. 1496 dated 06 March 2006 that include Makana Local Municipality in the list of municipalities intended to change the type from 3(f) [namely, a municipality with a plenary executive combined with a ward participatory system] to 3(b) [namely, a municipality with a collective executive system combined with a ward participatory system].

Makana Local Municipality remains as section 3(d) type [namely, a municipality with a mayoral executive system combined with a ward participatory system].
