

ACT 1 OF 2013(EC) - EASTERN CAPE FINANCE ACT, 2013 (EASTERN CAPE)

ACT

To authorise certain unauthorised expenditure in respect of 2009/2010, 2010/11, and 2011/12 financial years and to charge the Provincial Revenue Fund, and to provide for matters incidental thereto.

BE IT ENACTED by the Legislature of the Province of the Eastern Cape, as

follows:—

Authorisation of unauthorised expenditure from the Provincial Revenue Fund.

1. (1) The unauthorised expenditure to the amount of R1 575 465 000.00 incurred by the Eastern Cape Provincial Government during the period April 2009 to March 2012, and which the relevant Standing Committee on Public Accounts recommended for authorisation by the Legislature, is hereby authorised.
- (2) The expenditure referred to in subsection (1) is more fully described in the reports of the Standing Committee on Public Accounts as listed in Schedule 1 hereunder.
- (3) The expenditure is a direct charge against the Provincial Revenue Fund as envisaged in section 34(1)(a) of the Public Finance Management Act No. 1 of 1999, as amended.

Short title and commencement

2. This Act is called the Eastern Cape Finance Act, 2013 and shall be effective from the date it is assented into law by the Premier.


