



ACT NO 5 OF 2013 (EC) TRANSKEIAN DEVELOPMENT AND RESERVE FUND ACT, 2013 (EASTERN CAPE)

ACT

To provide for the repeal of the Transkeian Development and Reserve Fund Act; and to provide for matters incidental thereto.

ARRANGEMENT OF SECTIONS

- 10 1. Repeal of law
 - 2. Transitional Arrangements
 - 3. Short title and commencement
- BE IT ENACTED by the Legislature of the Province of the Eastern Cape as follows:-

Repeal of law

20 1. The Transkeian Development and Reserve Fund Act, 1964 (Act No. 3 of 1964) is hereby repealed.

Transitional Arrangements

- 25 2. (1) (a) All immovable assets registered in the name of the Transkeian Development and Reserve Fund and obligations attached thereto, on the date of commencement of this Act shall be transferred to the Department of Roads and Public Works.
- 30 (b) Any other immovable property which has been in custody of the Transkeian Development and Reserve Fund and obligations attached thereto, on the date of commencement of this Act shall be transferred to the Department of Roads and Public Works.
- 35 (2) All the cash and monies vested in the Transkeian Development and Reserve Fund at the date of commencement of this Act shall be transferred to the Provincial Revenue Fund.
- 40 (3) Any other liability accrued as of the date of the repeal be funded out of Provincial Revenue Fund upon motivation and appropriated to a relevant Department.



ACT NO 5 OF 2013 (EC) TRANSKEIAN DEVELOPMENT AND RESERVE FUND ACT, 2013 (EASTERN CAPE)

Short title and commencement

45 3. This Act is called the Transkeian Development and Reserve Fund Repeal Act, 2013, and comes into operation on a date of publication in the *Provincial Gazette*.
