**PROVINCIAL NOTICE 78 OF 2017****NOTICE OF LODGEMENT OF AN APPLICATION FOR AMENDMENT FOR A TOTALISATOR LICENCE TO INCLUDE ADDITIONAL PREMISES RELATING TO THE LICENCE IN TERMS OF THE GAMBLING AND BETTING ACT, 1997 (ACT NO. 5 OF 1997) (EASTERN CAPE) (as amended)**

**NOTICE IS HEREBY GIVEN** that application for an amendment for a totalisator licence to include additional premises to their licence in terms of section 37 of the Gambling and Betting Act, 1997 (Act No. 5 of 1997) (Eastern Cape) (as amended), the particulars of which are set out in the Schedule hereunder, has been lodged with the Eastern Cape Gambling and Betting Board.

The application may be inspected by any person at the offices of the Eastern Cape Gambling and Betting Board, ECGBB Building, Quenera Park, Quenera Drive, Beacon Bay, East London and at the offices of Nelson Mandela Bay Municipality, Port Elizabeth.

Any representations, including objections, petitions or comments shall be lodged with the Chief Executive Officer of the Board within one (1) month of the date of this notice, commencing on **8 May 2017 until 7 June 2017**.

All representations shall specify: the application to which the representations relates; in the case of an objection, the grounds on which the objection is founded; in the case of comment, full particulars or facts in substantiation thereof; the name, address, telephone and fax number of the person making the representations and a statement whether the person making the representations wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board should determine that his or her identity should not be divulged.

The under-mentioned figures used in brackets in the Schedule have the following meanings:

- (1) = The name and address of the applicant;
- (2) = If the applicant is a company or other corporate body, the names of all persons who have a financial or other interest of 5% or more in the applicant;
- (3) = In the case of a company the initials and surnames of all directors of the company;
