All representations shall specify: the application to which the representation relates; in the case of an objection, the grounds on which the objection is founded; in the case of comment; full particulars or facts in substantiation thereof: the name, address, telephone and fax number of the person making the representations and a statement whether the person making the representation when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.
