DRAFT REQUEST FOR PROPOSAL FOR A CASINO LICENCE

Notice is hereby given that the Draft Request for Proposal ("the Draft RFP") for a Casino Development in Zone 5 of the Eastern Cape will be available from **Monday, 06 November 2017** at the offices of the Eastern Cape Gambling and Betting Board ("the Board") situated at **Quenera Office Park, Quenera Drive, Beacon Bay, East London, daily between 09h00 – 15h00 (Mon – Fri)** against payment of a **non-refundable fee of R5000.00**, intended to cover printing, administration and other related costs.

The purpose of the Draft RFP is to invite written comments and suggestions from all interested parties and potential bidders, to highlight the requirements of the RFP, to draw attention to the EMR's, to explain the consequences of non-compliance and to explain the evaluation process. The draft RFP may be amended by the Board after consideration of the aforesaid written submissions and may culminate in the issue of a final RFP.

Please note that the final RFP will constitute the basis of any evaluation for any proposal for the Casino Development in Zone 5 and not the Draft RFP. The Draft RFP may substantially change in format and content when it reaches the final RFP stage and no liability for any change, damage or loss that may be incurred by any person as a result of this shall accrue/lie to the Board. Purchase of the Final RFP will be compulsory in respect of each application to be submitted.
