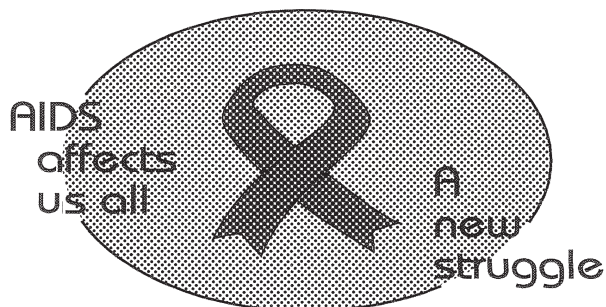

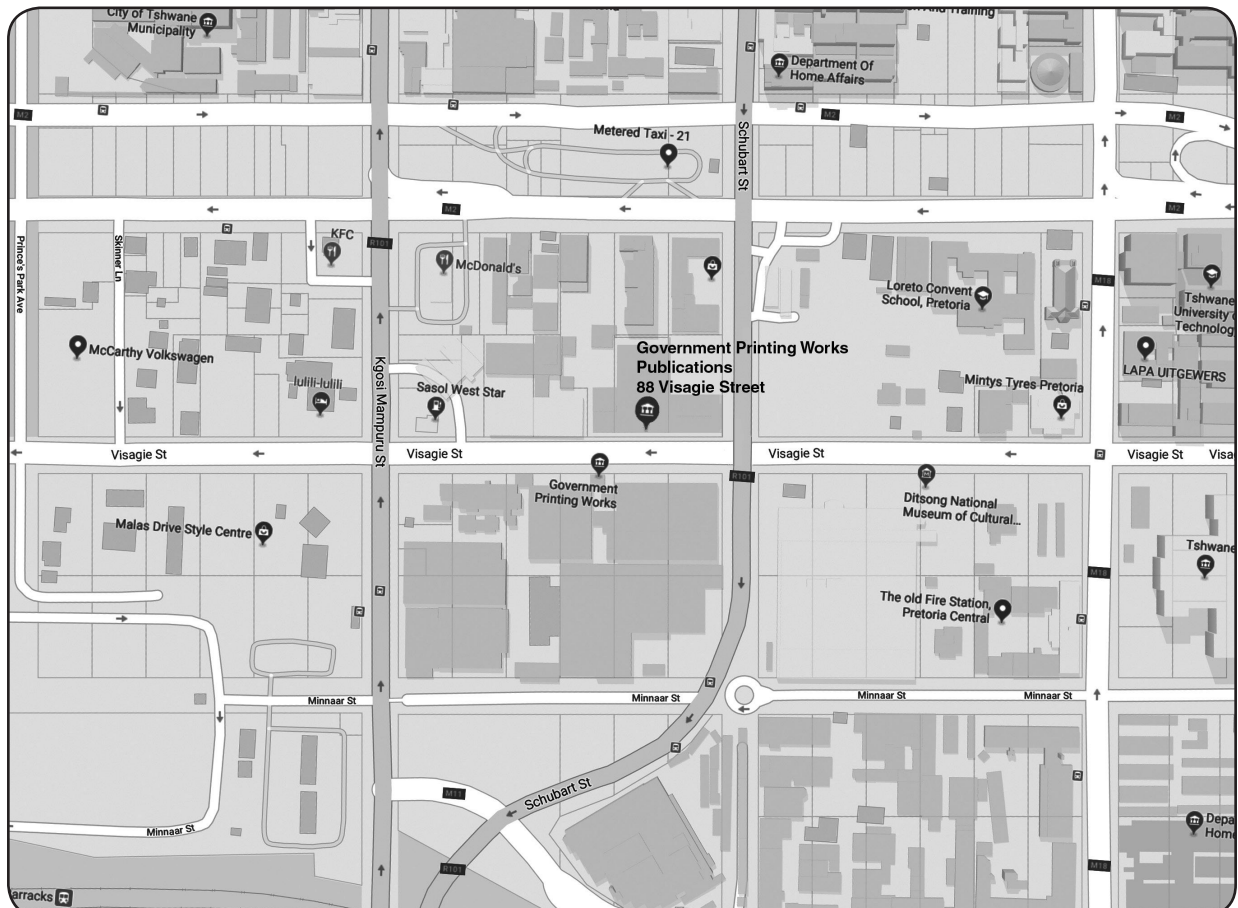

  - 3.3 your attention is drawn to the provisions of Section (9)(1) and 12(3)(a)(ii) of the last mentioned Act, as well as the fact that you must deliver or cause to be delivered to the address at the bottom of this notice, within sixty days from the Date of Notice, a written statement in which the following is set out:
    - 3.3.1 If, prior to the Date of Notice, the land was leased as a whole or in part by unregistered lease, the name and address of the lessee accompanied by the lease or a certified copy thereof if it is in writing, or full particulars of the lease if it is not in writing.
    - 3.3.2 If the land was sold prior to the Date of Notice, the name and address of the buyer accompanied by the contract of purchase and sale or a certified copy thereof.
    - 3.3.3 If a building has been erected on the land and such building is subject to a builder's lien by virtue of a written building contract, the name and address of the building contractor accompanied by the building contract or a certified copy thereof.
