PROVINCIAL NOTICE 194 OF 2020**AMENDMENT TO NOTICE OF LODGEMENT****NOTICE OF LODGEMENT OF AN APPLICATION FOR AMENDMENT OF LICENCE CONDITIONS IN TERMS OF THE GAMBLING AND BETTING ACT, 1997**

NOTICE IS HEREBY GIVEN that an application for amendment of licence conditions in terms of section 35 of the Eastern Cape Gambling Act, 1997 ("the Act") by **Goldrush Bingo Eastern Cape No. 5 (Pty) Ltd (2014/035210/07)** trading as **Goldrush Bingo Grahamstown** published on the Government Gazette and Daily Dispatch Newspaper on **Monday, 05 October 2020** is hereby amended by the addition of Schedule A hereunder.

The amendment to the above application has been lodged with the Eastern Cape Gambling Board in terms of Regulation 6(4) of the Eastern Cape Gambling Regulations 1998 (Provincial Notice No. 34 of 1998) ("the Regulations") to amend the current application before the Board.

Any objections, petitions or representations shall be lodged with the Chief Executive Officer of the Board within one (1) month of the date of this notice, which commences on **11 November 2020 until 10 December 2020**.

All objections and comments shall specify: the application to which the objection or comment relates; the grounds on which the objection is founded; in the case of comment; full particulars or facts in substantiation thereof: the name, address, telephone and fax number of the objector or person making the comment and a statement whether the objector or person making the comment wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.

The under-mentioned figures used in brackets in Schedules have the following meanings:
