**TRANSFER OF ADMINISTRATION AND POWERS AND FUNCTIONS
ENTRUSTED BY LEGISLATION FROM ONE MEMBER TO ANOTHER
MEMBER OF THE EXECUTIVE COUNCIL IN TERMS OF SECTION 137 OF
THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996.**

I, **Lubabalo Oscar Mabuyane**, Premier of the Province of the Eastern Cape, acting in terms of section 137 of the Constitution of the Republic of South Africa, 1996, hereby transfer the administration of and powers and functions entrusted by-

- (a) Chapter 5 of the Children's Act, 2005 (Act No. 38 of 2005) ("the Children's Act"), in respect of only partial care facilities that provide early childhood development services as defined in section 91(2) and early childhood development programmes as defined in section 91(3) of the Children's Act;
- (b) Chapter 6 of the Children's Act; and
- (c) Chapters 20 and 21 of the Children's Act only in respect of the powers transferred in paragraphs (a) and (b) ,

in so far as they relate to the MEC of Social Development, from such MEC to the MEC of Education, with effect from 01 April 2022.

Any reference to the MEC of Social Development in so far as it relates to the powers and functions in Chapter 5, 6 and section 309 of the Children's Act must be interpreted as reference to the MEC of Education.
