I, **Mlungisi Mvoko**, in my capacity as Member of Executive Council (MEC) responsible for Economic Development, Environmental Affairs and Tourism in the Eastern Cape and acting in terms of Section 53(1)(c) of the National Environmental Management: Integrated Coastal Management Act (Act No. 24 of 2008) hereby give notice of my intention to establish an Estuarine Management Plan (EMP) for the Tyolomnqa Estuary, located within the Buffalo City Metropolitan Municipality, approximately 45km south of East London, in the Province of the Eastern Cape.

Members of the public are invited to submit written representations, comments or objections that they may have on the draft EMP, within 30 (thirty) days from the date of publication of this notice in the Gazette. The 30 days commenting period will exclude the period between 15 December 2023 to 05 January 2024. The remainder of the 30 days' commenting period will continue on the 6th January 2024 and will be extended for same number of days that fell in the December closure period
