## Free State Local Government Laws Rationalisation Act, 2004 Act 2 of 2004

## ACT

**To rationalise the local government laws applicable to the Province of the Free State that became obsolete as a result of the laws that were enacted since 1994; and to provide for matters connected therewith.**

Be IT ENACTED by the Provincial Legislature of the Free State, as follows:-

### **1. Repeal of legislation**

The legislation specified in the first column of the Schedule is hereby repealed to the extent indicated in the second column of the Schedule.

### **2. Short title**

This Act is called the Free State Local Government Laws Rationalisation Act, 2004.
