**MUNICIPAL DEMARCATIION BOARD  
DELIMITATION OF MUNICIPALWARDS IN TERMS OF THE LOCAL GOVERNMENT:  
MUNICIPAL STRUCTURES ACT, 1998**

**MUNICIPALITY : FS204**

In terms of item 5(2) of Schedule 1 of the Local Government: Municipal Structures Act, 1998 (Act No.117 of 1998) the Municipal Demarcation Board considered written objections to its delimitation of wards for the above-mentioned municipality and has confirmed, varied or withdrawn its determination as indicated in the Schedule.

Provincial Gazette No 49 of 8 May 2000 is hereby withdrawn.

**SCHEDULE**

In terms of section 18(3) of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998) the MEC for local government has determined that the municipal council consists of 33 councillors. After having consulted the Independent Electoral Commission, The Municipal Demarcation Board has delimited the municipality into 17 wards in terms of Schedule 1 of the Act.

The number of registered voters in each ward does not vary by more than fifteen percent from the norm. The norm was determined by dividing the total number of voters on the municipal segment of the national common voters roll, namely 53791 voters on 31 March 2000, by the number of wards in the municipality.
