

CONDITIONS OF ESTABLISHMENT AND OF TITLE

The township is Extension 161 of Bloemfontein and is situated on portion 368 of the Farm Bloemfontein No. 654, in the district of Bloemfontein. The portion consists of Erven No's 26790 - 26954 and streets as indicated on General Plan No. SG 1132/2001.

A. CONDITIONS OF ESTABLISHMENT

A.1 All Erven

All rights to minerals are reserved in favour of the Mangaung Local Municipality.

A.2 Erf 26954 adjacent to the 28 metre main collector road.

No access is permitted for motor vehicles to and from the erf to the adjacent 28 metre road reserve (south east).

A.3 Precautionary Measures

Erven 26790 - 26954

The erven lies in an area where soil conditions can effect buildings and structures and result in damage to them. Building plans submitted to the Local Municipality must show measures to be taken, in accordance with recommendations obtained in the geotechnical report for the township compiled by Soilkraft CC, to limit possible damage to buildings and structures as a result of detrimental foundation conditions, unless it is proved to the Local Municipality that such measures are unnecessary or that the same purpose can be achieved by other more effective means.

A.4 The erven of this township are divided into the following groups and stipulated in the Bloemfontein Town Planning Scheme, 1954 and are further subject to the Conditions of Title, as set out in paragraph B.

Die dorp is Uitbreiding 161 van Bloemfontein en is geleë op gedeelte 368 van die Plaas Bloemfontein No. 654, in die Bloemfontein distrik. Die gedeelte bestaan uit Erwe No's 26790 tot 26954 en strate soos aangedui op Algemene Plan No. L G 1132/2001.

A. STIGTINGSVOORWAARDES

A.1 Alle erwe

Alle regte tot minerale word gereserveer ten gunste van Mangaung Plaaslike Munisipaliteit.

A.2 Erf 26954 aanliggend tot die 28 meter hoof versamelpoort.

Geen toegang vir motorvoertuie na en vanaf hierdie erf tot die aangrensende 28 meter straatreserwe (suid-oos) word toegelaat nie.

A.3 Voorkomende maatreëls

B. CONDITIONS OF TITLE

The Conditions of Title mentioned in paragraph A.4 are as follows:

IN FAVOUR OF THE MANGAUNG LOCAL MUNICIPALITY

- B.1 This erf is subject to a 2 metre wide servitude along any of its boundaries except the street boundary and in the case of a panhandle erf, the entire access portion (handle) of the erf, as well as any other servitude for municipal service conductors over or under the erf indicated on the General Plan for the Township, and the officials of the City Council have free access thereto at any time for the purpose of construction, maintenance and repair of services.

Hierdie erf mag vir woondoeleindes gebruik word gesaam met die volgende geboue wat gebruik mag word om mense te huisves en hulle met maaltye te bedien. Konferensie fasiliteite mag ook, soos volg voorgeskryf, voorsien word.
Die vier bestaande huise mag omskep word in 'n maksimum van drie eenhede elk vir die akkommodasie van mense.
Die hostel mag omskep word in 'n maksimum van 12 eenhede.
Die bestaande vyf woonstelle mag omskep word om mense te akommodeer.
'n Maksimum van tien huthuisies mag opgerig word.
Die bestaande saal mag gebruik word vir konferensie doeleindes.
Die bestaande eetsaal en kombuis mag vir daardie doel behou word.

Any other buildings on the erf or any new buildings may be used to accommodate people provided that at no time may more than 100 (one hundred) people be accommodated on the erf. An office of maximum 150sq metres may be accommodated on the erf.

Parking requirements are one parking bay per unit and for the dwelling four parking bays have to be provided plus an additional 20 % of the number of residential parking bays to be provided in close proximity of the conference hall. All parking must be provided on the erf.

NOTICE REGARDING THE FORMAT OF APPLICATIONS IN TERMS OF SECTION 37 OF THE NATIONAL LAND TRANSPORT TRANSITION ACT, 2000

Under the powers vested in me by section 37(1) of the National Land Transport Transition Act, 2000 (Act No. 22 of 2000) (hereafter referred to as "the Act"), I, S M A Malebo, Member of the Executive Council responsible for transport in the Province, hereby determine, as set out in the Schedule, the manner and time required for giving notice of receipt of an application.

SCHEDULE

1. The Permit Board must publish the following particulars of the applications in the notice or make such particulars available for inspection at the Office of the Board, as contemplated in section 37 of the Act:
 - (i) Number of application;
 - (ii) Name of applicant;
 - (iii) The place where the applicant conducts business;
 - (iv) Postal address of applicant;
 - (v) Vehicle particulars of applicant;
 - (vi) Number of permits that are affected by application;
 - (vii) Particulars in relation to the conveyance of taxi passengers; and
 - (viii) Particulars in relation to the numbers allocated to routes and route networks, which the applicant currently operates on.

Continue for 0.8 km to the entrance to the Farm Libanon (stop 93) (251.6 km). Proceed along Road R26 for 2.5 km, reaching the junction of road S10 with Road R26 (stop 94) (254.1 km). Proceed 3.2 km to the entrance of the De Hoek Roadside Stall (stop 95) (257.3 km), and proceed. Having completed 1.8 km, (stop 96) (260.5 km) is at the junction of the S217 and the entrance to the Farm Barnea off Road R26. Return journey the same as the forward but in the opposite direction, except at **Bethlehem**, where between stops 97 and 96 the following shall apply : entering Bethlehem via Johan Blignault Avenue, which becomes Hospital Street, turn left into the slipway of Eeufees Street and continue along Eeufees Street. Having crossed the Jordan River Eeufees Street becomes Kerk Street. Continue along Kerk Street upto its junction with Commisioner Street, turning right into the latter and proceeding to stop 96 as described above.
