ALLOCATION TO MUNICIPALITIES NOT LISTED IN SCHEDULES TO THE DIVISION OF REVENUE ACT, 2002 (ACT NO. 5 OF 2002)

1. Transferring Provincial Department	Department of Health
2. Purpose	To render Comprehensive Primary Health Care Services inclusive of Tuberculosis and Environmental Health Services
3. Measurable outputs	Projected spending, territory in which services are to be rendered (urban or rural), per capita population, poverty status, infant mortality rate, immunisation coverage and tuberculosis conversion rates
4. Conditions	Payment are made in accordance with Article 26 of the Health Act 1977 (act 63 of 1977) on a subsidy basis, and subject to the conditions as prescribed in Section 38(1)(j) of the Public Finance Management Act, 1999 (Act 1 of 1999), National Treasury Regulations 8.4 and Provincial Treasury Directive 8.6. Financial statements, claims and audited reports are submitted
5. Allocation criteria	According to Service Level Agreements with Local Municipalities with effect from 1 April 2002. The Formula of allocations includes population per capita per municipal area. Additional criteria given to special projects e.g. Mother to Child Transmission (HIV/AIDS) and TB co-ordinators. Working towards equity between the local administrations.
