**DECLARATION AS A SECTION OF THE MOEDERSGIFT—NOOTGEDACHT TERTIARY ROAD T5629, A-B, SITUATED IN THE MAGISTERIAL DISTRICT OF BOSHOF (LENGTH ± 1,0 km):**

From point A on the boundary line between Hebron 1472 and Nootgedacht 386, where it will leave tertiary road T5629; thence over Nootgedacht 386, to point B on the boundary line between Nootgedacht 386 and Subdivision 1 of Vleiplaats 1595.

The proposal is indicated approximately on a plan in the offices of the Roads Superintendent, Petrusburg and the Head: Public Works, Roads and Transport.
