BILL

To repeal the Exchequer Act, as amended, and to provide for matters connected therewith.

BE IT ENACTED by the Provincial Legislature of the Free State Province, as follows:-

Repeal of Acts

1. The acts mentioned in the Schedule are hereby repealed. 5

Savings

2. Anything done in terms of the provisions of the Exchequer Act, 1994, as amended, repealed in terms of section 1, shall be deemed to have been done under corresponding provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), the regulations promulgated and the treasury instructions issued in terms of the Public Finance Management Act, 1999. 10

Short title

3. This Act is called the Exchequer Act Repeal Act, 2002. 15

MEMORANDUM

The Exchequer Act, 1994, together with its amendments were in essence enacted to regulate and control State moneys, the disposal of State property, the powers of the Treasury, as well as other issues such as the granting of guarantees and indemnities. This Act focused more on expenditure control than on financial accountability. However, during 2000, the Public Finance Management Act, 1999, came into operation. Latter Act adopts an approach to financial management, which focuses on outputs and responsibilities, rather than the rule driven approach of the Exchequer Act. The Public Finance Management Act, 1999, superceded the provincial exchequer acts. It is therefore recommended that the Exchequer Act, 1994, together with its amendments be repealed.

Clause 1

This clause repeals the Exchequer Act and its amendments.

Clause 2

This clause makes provisions for a savings clause.

Clause 3

This clause gives the short title.

MEMORANDUM

Die Skatkiswet, 1994, met sy wysigings, is wesenlik verorden om staatsgeld, beskikking oor staatseiendom, die bevoegdhede van die Tesourie asook ander sake soos die toestaan van waarborge en vrywarings te reël en te beheer. Hierdie Wet was meer toegespits op uitgawebeheer as op finansiële aanspreeklikheid. In 2000 het die Wet op Openbare Finansiële Bestuur, 1999, egter in werking getree. Laasgenoemde Wet volg 'n benadering tot finansiële bestuur wat toegespits is op resultate en verantwoordelikhede eerder as die reëlgedreve benadering van die Skatkiswet. Die Wet op Openbare Finansiële Bestuur, 1999, het die provinsiale skatkiswette vervang. Daar word dus aanbeveel dat die Skatkiswet, met sy wysigings, herroep word.
