NOTICE OF AUTHORISATION IN TERMS OF SECTION 85 OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998

I, Solomon Lechesa Tsenoli, Member of the Executive Council responsible for Local Government in the Free State Province, acting in terms of section 85(1) and (6) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), and on recommendations of the Municipal Demarcation Board, hereby authorise district municipalities and local municipalities to perform the functions or exercise the powers as set out in the Schedule hereto.

SCHEDULE

Definitions

- 1. In this Schedule, unless inconsistent with the context, a word or expression to which a meaning has been assigned in the Structures Act, Chapter 2 of the Amendment Act and the section 12 notice has the same meaning and
 - "Amendment Act" means the Local Government: Municipal Structures Amendment Act, 2000 (Act No. 33 of 2000);
 - "district municipality" means the Category C municipality established in terms of the section 12 Notice.
 - "local municipality" means the Category B municipality established in terms of the section 12 notice.
 - "Schedule 4" means Schedule 4 of the Constitution of the Republic of South Africa, 1996 (Act No 108 of 1996);

"section 12 notice" means;

- (a) Provincial Notice No181 of 2000 dated 28 September 2000 published in Provincial Gazette No.109 of 28 September 2000;
- (b) Provincial Notice No182 of 2000 dated 28 September 2000 published in Provincial Gazette No.110 of 28 September 2000;
- (c) Provincial Notice No183 of 2000 dated 28 September 2000 published in Provincial Gazette No.111 of 28 September 2000;
- (d) Provincial Notice No184 of 2000 dated 28 September 2000 published in Provincial Gazette No.112 of 28 September 2000, and
- (e) Provincial Notice No185 of 2000 dated 28 September 2000 published in Provincial Gazette No.113 of 28 September 2000,

which established the district municipality and local municipalities specified therein in terms of the Structures Act;

"Section 84" refers to section 84 of the Structures Act including its subparagraphs, and

"Structures Act" means the Local Government. Municipal Structures Act, 1998 (Act No 117 of 1998).

Repeal of Notice

2. Provincial Notices No. 53 of 10 April 2002 and 12 of 14 January 2003 is hereby repealed with effect from 30 June 2003.

Authorisation

3. Responsibility and accountability

4. A municipality which is authorised in terms of paragraph 3 to perform a function or exercise a power, must assume full responsibility and accountability for those functions or powers and their effective and efficient performance or exercise, as the case may be, or any aspect thereof as being performed by that municipality on the date of commencement of this notice.

Legal, practical and other consequences of the authorisation

- 5. The provisions regarding -
 - (a) the transfer of assets, rights, liabilities and obligations;
 - (b) the transfer of staff;
 - (c) administrative units; and
 - (d) the continued application of by-laws and resolutions,

as set out in the section 12 notice, apply with the necessary changes required by the context, to the performance of a function or exercise of a power by a municipality that is authorised to perform such function or exercise such power in accordance with this Notice.

Commencement

6. This authorisation shall be effective from 1 July 2003
