Call for applications for the post of a Public Service Commissioner for the Free State Province in terms of the Constitution of the Republic of South Africa, 1996 (Act 108 of 1996) and the Public Service Commission Act 1997 (Act 46 of 1997)

In terms of the provisions of section 196 of the Constitution, 1996, read with section 4 of the Public Service Commission Act, 1997, the Free State Province hereby invites applications for the position of Commissioner who will serve on the Public Service Commission.

The Public Service Commission is independent and must be impartial and exercise its powers and perform its functions without fear, favour or prejudice in the interest of the maintenance of an effective and efficient public administration and a high standard of professional ethics in the public service.

The candidate must meet the following requirements and she/he will be appointed by the President of the Republic of South Africa on that basis: (i) Must be a South African citizen, (ii) Shall be a fit and proper person with knowledge of or experience in administration, management or the provision of public services, (iii) May not hold office in any political party / organization and (iv) Shall not, without consent of the President of the Republic of South Africa, perform or engage herself /himself to perform any remunerative work outside the duties of her/his office.

Commissioners shall hold office for a term of five years renewable for one additional term only and shall be remunerated as determined by the President of the Republic of South Africa.






