NOMINATION OF CANDIDATES FOR APPOINTMENT AS MEMBERS OF THE FREE STATE OPERATING LICENSING BOARD

Under section 42(4)(a) of the Free State Public Transport Act, 2005 (Act No. 4 of 2005), I, TM Manyoni, Member of the Executive Council responsible for Police, Roads and Transport in the Province, hereby invite applications for nominations of persons who wish to be appointed as members of the Free State Operating Licensing Board.

Invitations for nominations must be accompanied by:

- (a) nominee's acceptance letter;
- (b) curriculum vitae of the nominee;
- (c) certified copies of the nominee's educational qualifications;
- (d) certified copies of the nominee's professional registration certificates;
- (e) an indication of the district for which the nominee is going to be appointed.

Disqualification from being appointed as a member of the Free State Operating Licensing Board:

- (a) if a nominee is a minor or is mentally incapable of handling his or her own affairs;
- (b) if a nominee is an unrehabilitated insolvent;
- (c) if a nominee has been convicted of an offence involving dishonesty or has been removed from public office on account of misconduct; and
- (d) if a nominee's spouse or partner, immediate family, dependant, business partner or employer has a financial interest in the business of public transport or is an elected office-bearer in association or is engaged in an activity which, in the opinion of the MEC, will interfere with the impartial discharge of the functions of his or her duties.

The chairperson of the Free State Operating Licensing Board will be appointed for a period not exceeding eighteen months and other members of the Board for a period not exceeding eighteen months and all members hold the office on conditions as to remuneration as the MEC may determine when they are appointed.

Persons with disabilities may be nominated for appointment.
