a) BAINSVLEI: AMENDMENT OF THE TOWN-PLANNING SCHEME

- a) Amend Clause 1 of the Bainsvlei Town Planning Scheme, 1984 (No. 1 of 1984) by the inclusion of the definition for "Neighbourhood Shopping Centre" that reads as follows:

"Neighbourhood Shopping Centre": means a mixed development comprising of shops and business buildings that serve the local community and are limited in scale, with ancillary parking and landscaping (see also classification by the South African Council of Shopping Centres).

- b) Amendment Table C of the Bainsvlei Town Planning Scheme, 1984 (No. 1 of 1984) by the insertion of the new zoning "Special Use 71", that reads as follows:
