# **PROVINCIAL NOTICE**

# TRADITIONAL AND KHOI-SAN LEADERSHIP ACT, 2019 (ACT NO. 3 OF 2019)

## ESTABLISHMENT OF THABO MOFUTSANYANA LOCAL HOUSE OF TRADITIONAL AND KHOI-SAN LEADERS

In terms of section 50(1) of the Traditional and Khoi-San Leadership Act, 2019 (Act No. 3 of 2019), I, S H Ntombela, Premier of the Free State Provincial Government, hereby establish the Thabo Mofutsanyana Local House of Traditional and Khoi-San Leaders for the area of jurisdiction of the Thabo Mofutsanyana District Municipality with effect from the date of publication of this Notice in the *Provincial Gazette* and, in terms of section 50(12) of the said Act, issue the regulations set out in the Schedule hereunder with effect from the said date.

### **SCHEDULE**

Regulations in terms of section 50(12) of the Traditional and Khoi-San Leadership Act, 2019 (Act No. 3 of 2019)

#### **Definitions**

1. In these Regulations any word or expression defined in the Traditional and Khoi-San Leadership Act (Act No. 3 of 2019) (the Act), shall bear such meaning unless the context indicates otherwise and "local house" shall, in addition to the definition in the Act, mean the Thabo Mofutsanyana Local House of Traditional and Khoi-San Leaders.

# Composition, term, first meeting and quorum of local house

- 2. (1) As contemplated in section 50(3) of the Act, all recognised senior traditional leaders and senior Khoi-San leaders who reside within the area of jurisdiction of the Thabo Mofutsanyana District Municipality are, subject to subregulation (2), members of the local house.
  - (2) Senior Khoi-San leaders within the Thabo Mofutsanyana District Municipality will become members of the local house upon official recognition as contemplated in section 58 of the Act, for the remainder of the term of the local house.
  - (3) As contemplated in section 50(8) of the Act, the term of the local house expires on 30 April 2027.
  - (4) Following the establishment of the local house, the first meeting of the local house for purposes of the election of the chairperson and deputy chairperson of the local house, must take place on a date and at a time and place determined by the Member of the Executive Council (MEC) responsible for traditional and Khoi-San leadership within the province: Provided that such meeting must be held within 45 days from the date of establishment of the local house.
  - (5) The quorum for any meeting of the local house shall be fifty percent plus one of the total number of members at the time of the meeting: Provided that a vacancy shall not be counted for purposes of determining the total number of members of the local house.

## Oath or solemn affirmation

3. The members of the local house must, before they begin to perform their functions in the local house, take an oath or solemn affirmation as set out in Schedule 2 of the Act, before a judge of the High Court designated by the Judge President for this purpose.

# Election of the chairperson and deputy chairperson of the local house

- 4. (1) After compliance with regulation 3 by members of the local house, the judge contemplated in regulation 3 shall preside over the election of the chairperson of the local house from amongst the members of the local house, followed by the election of the deputy chairperson from amongst such members.
  - (2) The following procedures apply to the election of the chairperson and deputy chairperson of the local house:
    - (a) The judge must call for nominations of persons to be considered as chairperson of the local house.
    - (b) Each nomination must be seconded by another member of the local house.
    - (c) Each nominated person must indicate whether he or she accepts or declines the nomination.
    - (d) If only one person is nominated as chairperson, the judge must declare the person as duly elected.
    - (e) If there is more than one nomination for the position of chairperson, the judge must request members to indicate whether they wish to vote by means of a show of hands or secret ballot.
    - (f) If voting is to take place by a show of hands, the judge must read out the names of the nominated candidates in alphabetical order and allows time after each name has been read for members to vote by a show of hands.
    - (g) If members prefer a secret vote, the judge must request the officials referred to in sub-regulation (3) to prepare a ballot paper.
    - (h) The judge must call on members of the local house to, one at a time, move to the appropriate area provided for in the particular venue where such member will be provided with a ballot paper.
    - (i) A member of the local house must make his or her mark next to the candidate he or she is voting for and place the ballot in a ballot box provided for this purpose.
    - (j) Once all ballots have been cast, the judge must request the officials referred to in sub-regulation (3) to open the ballot box in front of all members of the local house, to count the number of votes in respect of each nominated candidate and to hand the result to the judge.
    - (k) The judge must announce the outcome of the vote and declare the person who received the majority of votes as the duly elected chairperson.
    - (I) The processes referred to in paragraphs (a) to (k) apply with the necessary changes to the election of the deputy chairperson of the local house.
  - To assist with the administrative processes contemplated in sub-regulation (2), the MEC referred to in regulation 2(4) may designate one or more official from his or her Department.

# Filling of vacancies

5. In the event that a vacancy in the local house arise, such vacancy shall be filled by the successor to the relevant senior traditional leader or senior Khoi-San leader, as the case may be, with effect from the date of official recognition of such successor and for the remainder of the term of the local house.
