PROCEDURES AND ADVERTISEMENT DATES FOR THE ADVERTISEMENT OF LICENSES APPLICATIONS IN THE FREE STATE PROVINCIAL GAZETTE, ACCORDING TO THE FREE STATE GAMBLING, LIQUOR AND TOURISM ACT, 2010 (ACT NO. 6 OF 2010 AS AMENDED)

In terms of the Free State Gambling, Liquor and Tourism Act, 2010 (Act No. 6 of 2010 as amended) and related regulations, all applications for licenses submitted to the Free State Gambling, Liquor and Tourism Authority must be accompanied, among others, with proof of publication in the Provincial Gazette and in at least one newspaper normally circulated in the area where the premises are situated.
