# **BILL**

**To repeal certain laws; to amend certain laws; and to provide for matters incidental thereto.**

**BE IT ENACTED** by the Provincial Legislature of the Free State Province as follows:-

**Repeal of laws**

1. The laws mentioned in Schedule 1 are hereby repealed to the extent set out in the third column of the Schedule. 5

**Amendment of laws**

2. The laws that are mentioned in Schedule 2 are amended to the extent set out in the third column of the Schedule. 10

**Short title**

3. This Act is called the General Laws Repeal Act, 2022. 15

## MEMORANDUM

### **1. PURPOSE**

There still exist a number of unused or irrelevant pieces of legislation. Some of the legislation was enacted by the defunct homeland and provincial administration legislatures. Some of the laws deal with issues that have been addressed in national or provincial legislation.

In order to ensure legal certainty and uniformity in the Province, as part of an ongoing rationalization process, there is legislation in place that address the deficiencies.

### **2. CLAUSE-BY-CLAUSE EXPLANATION**

#### **Section 1**

Section 1 contains a schedule in which laws that are repealed and the extent to which they are repealed, are listed. The reasons for the repeal are explained hereunder.

## MEMORANDUM

### 1. DOEL

Daar bestaan steeds 'n aantal ongebruikte of ontoepaslike stukke wetgewing. Sommige van die wette is deur die ontbinde tuisland- en provinsiale administrasie-wetgewers uitgevaardig. Sommige van die wette handel oor kwessies wat in nasionale of provinsiale wetgewing aangepak is.

Ten einde regsekerheid en eenvormigheid in die Provincie te verseker, as deel van 'n deurlopende rasionaliseringsproses, is wetgewing in gereedheid gebring wat die tekortkominge aanpak.
