Under the powers vested in me by section 9 (2) of the Local Government Transition Act, 1993 (Act No. 209 of 1993), and regulation 100A (1) of the Local Government Transition Election Regulations, 1994 as amended, I hereby extend the dates determine in regulations 41 (6) and 34 (3) as follows:

- (1) Publication of list of candidates, polling stations and addresses from 22 September 1995 to 17 October 1995.
- (2) Agents and Messengers from 12 October 1995 to 20 October 1995.

This Proclamation shall come into operation with immediate effect and shall be applicable to all transitional authorities in the Gauteng Province.
