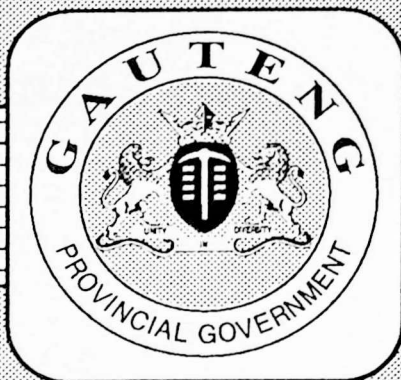

## **NOTICE 1175 OF 2000**

### **MUNICIPAL DEMARCATION BOARD NOTICE IN TERMS OF SECTION 21 OF THE LOCAL GOVERNMENT : MUNICIPAL DEMARCATION ACT, 1998 AND THE BOARD'S PROPOSALS FOR MUNICIPAL BOUNDARIES EXTENDING ACROSS PROVINCIAL BOUNDARIES ENVISAGED IN SECTION(6A) OF THE CONSTITUTION, 1996**

#### **BOUNDARIES OF CATEGORY A, B AND C MUNICIPALITIES**

In terms of section 21 of the Local Government: Municipal Demarcation Act, 1998 (Act No.27 of 1998) the Municipal Demarcation Board, has considered all objections and has confirmed, varied or withdrawn its determination of the municipal boundaries of category A (metropolitan), category B (local) and category C (district) municipalities. The Board's redeterminations in terms of section 21(1)(b) are reflected in Schedule 1.

Notice No. 7831 of 1999 published in Provincial Gazette No. 107 of 22 November 1999 and Notice No. 8484 of 1999 published in Provincial Gazette No. 113 of 20 December 1999 are hereby withdrawn.

#### **PROPOSED BOUNDARIES FOR MUNICIPALITIES EXTENDING ACROSS PROVINCIAL BOUNDARIES**

The Board's proposals for municipal boundaries extending across provincial boundaries are reflected in the maps appearing in schedule 2. The determination of these boundaries in terms of section 21 of the Local Government: Municipal Demarcation Act, 1998 is subject to the concurrence of the provinces concerned and the national legislation envisaged in section (6A) of the Constitution, 1996.

 GAUTENG AND NORTH WEST.

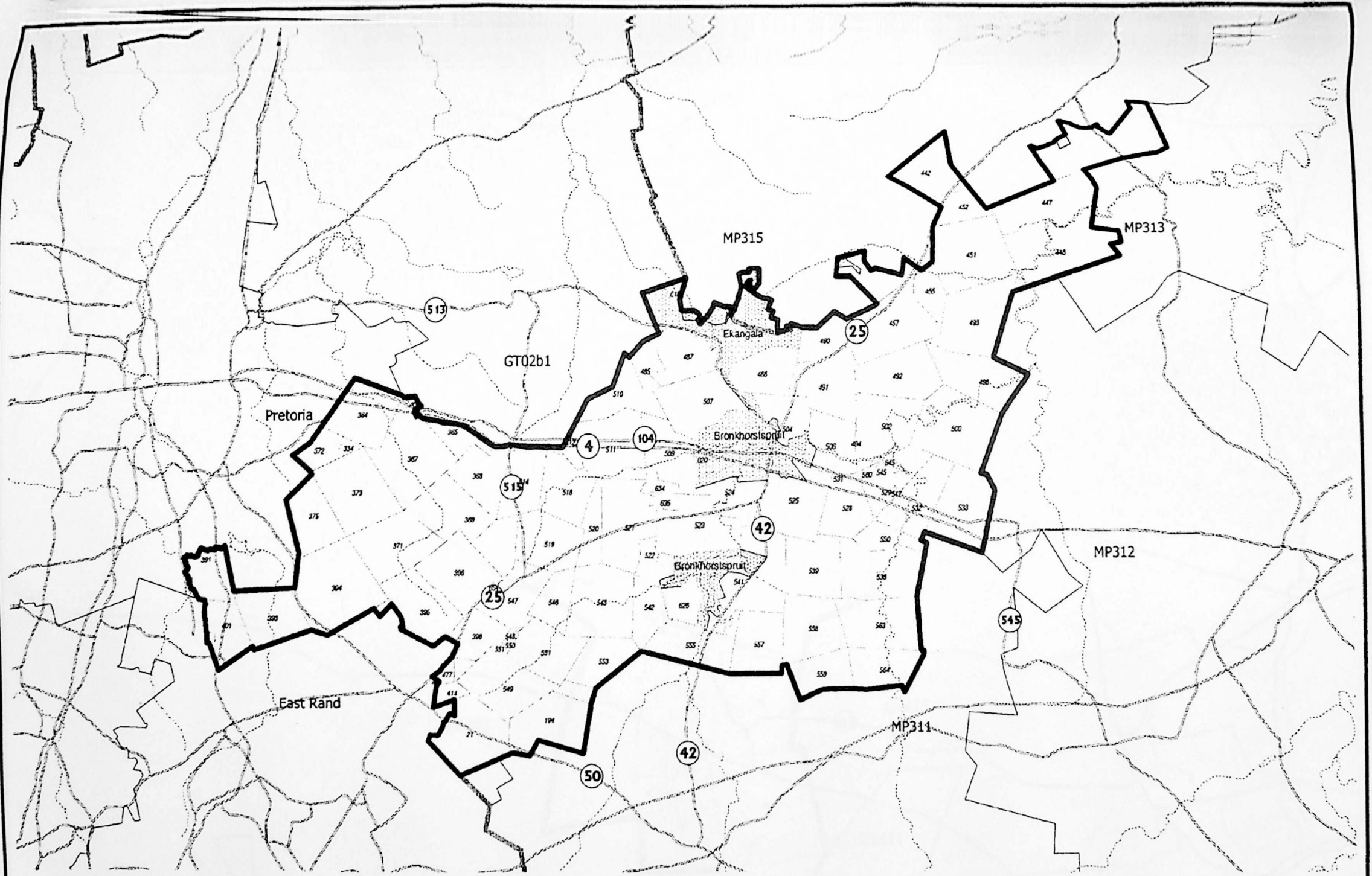

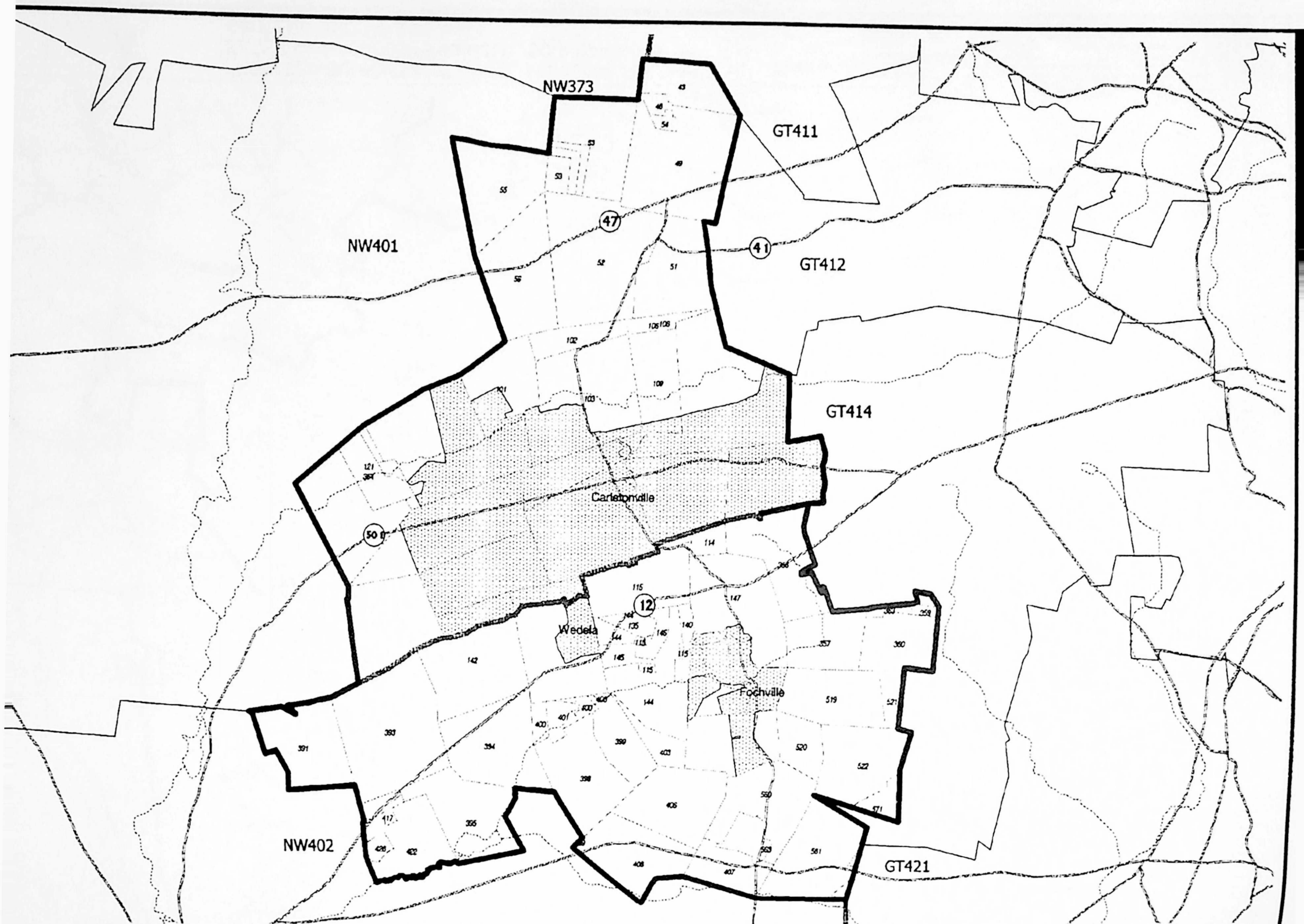


PROPOSED BOUNDARY OF LOCAL MUNICIPALITY CBL2
