



## BILL

**To determine the types of municipality that may be established in the Province; and to provide for matters in connection therewith**

**B**E IT ENACTED by the Gauteng Provincial Legislature as follows:—

### Definitions

**1.** In this Act, unless the context otherwise indicates, a word or expression to which a meaning has been assigned in the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), has a similar meaning, and—

**“collective executive system”** means a system of municipal government, which allows for the exercise of executive authority through an executive committee in which the executive leadership of the municipality is collectively vested;

**“mayoral executive system”** means a system of municipal government, which allows for the exercise of executive authority through an executive mayor in whom the executive leadership of the municipality is vested and who is assisted by a mayoral committee;

**“plenary executive system”** means a system of municipal government, which limits the exercise of executive authority to the municipal council itself;

**“Province”** means the Province of Gauteng;

**“subcouncil participatory system”** means a system of municipal government which allows for delegated powers to be exercised by subcouncils established for parts of the municipality; and

**“ward participatory system”** means a system of municipal government, which allows for matters of local concern to wards to be dealt with by committees established for Awards.

#### **Category A municipalities**

2. In the category A the following types of municipality may be established in the Province:
- (a) A municipality with a collective executive system;
  - (b) a municipality with a collective executive system combined with a subcouncil participatory system;
  - (c) a municipality with a collective executive system combined with a ward participatory system;
  - (d) a municipality with a collective executive system combined with both a subcouncil and a ward participatory system;
  - (e) a municipality with a mayoral executive system;
  - (f) a municipality with a mayoral executive system combined with a subcouncil participatory system;
  - (g) a municipality with a mayoral executive system combined with a ward participatory system; and
  - (h) a municipality with a mayoral executive system combined with both a subcouncil and a ward participatory system.

#### **Category B municipalities**

3. In category B the following types of municipality may be established in the Province:
- (a) A municipality with a collective executive system;
  - (b) a municipality with a collective executive system combined with a ward participatory system;
  - (c) a municipality with a mayoral executive system;
  - (d) a municipality with a mayoral executive system combined with a ward participatory system;
  - (e) a municipality with a plenary executive system; and
  - (f) a municipality with a plenary executive system combined with a ward participatory system.

#### **Category C municipalities**

4. In category C the following types of municipality may be established in the Province:
- (a) A municipality with a collective executive system;
  - (b) a municipality with a mayoral executive system; and
  - (c) a municipality with a plenary executive system.

#### **Short title and commencement**

5. This Act is called the Gauteng Types of Municipality Act, 2000.

**EXPLANATORY MEMORANDUM**

**1. BACKGROUND**

- 1.1 In terms of the provisions of section 155 (5) of the Constitution, 1996 and section 11 of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), provincial legislation must be passed which provides for the determination of the different types of municipality that may be established in the Province.
- 1.2 To give effect to the provisions of the Constitution and the Local Government: Municipal Structures Act, 1998, the Gauteng Types of Municipality Bill, 2000, has been drafted.

**2. PURPOSE OF BILL**

- 2.1 The purpose of the Bill is to determine the types of municipality that may be established in the Province.

**3. CLAUSE-BY-CLAUSE DESCRIPTION**

- 3.1 **Clause 1:**  
This clause contains definitions.
- 3.2 **Clause 2:**  
This clause makes provision for the types of municipality that may be established in category A municipalities.
- 3.3 **Clause 3:**  
This clause makes provision for the types of municipality that may be established in category B municipalities.
- 3.4 **Clause 4:**  
This clause makes provision for the types of municipality that may be established in category C municipalities.
- 3.5 **Clause 5:**  
This clause contains the short title of the Bill.

## Definisies

1. In hierdie Wet het 'n woord of begrip, waaraan 'n betekenis in die Wet op Plaaslike Regering: Munisipale Strukture (Wet No. 117 van 1998), geheg is, 'n soortgelyke betekenis, tensy die konteks dit anders aandui, en—

“**gesamentlike uitvoerende-stelsel**” beteken 'n stelsel van munisipale regering, wat voorsiening maak vir die uitoefening van uitvoerende gesag deur 'n uitvoerende komitee, waarin die uitvoerende leierskap van die munisipaliteit gesamentlik gevestig is;

“**burgemeesters-uitvoerende-stelsel**” beteken 'n stelsel van munisipale regering, wat voorsiening maak vir die uitoefening van uitvoerende gesag deur 'n uitvoerende burgemeester, op wie die uitvoerende leiding van die munisipaliteit oorgaan en wat deur 'n burgemeesterskomitee bygestaan word;

“**volle raad-uitvoerende-stelsel**” beteken 'n stelsel van munisipale regering, wat die uitoefening van uitvoerende gesag tot die munisipale raad beperk;

“**Provinsie**” beteken die Provinsie van Gauteng;

“**subraad-deelnemende-stelsel**” beteken 'n stelsel van munisipale regering, wat daarvoor voorsiening maak, dat gedelegeerde magte uitgeoefen mag word deur subrade, wat vir dele van die munisipaliteit ingestel word; en

“**wyk-deelnemende-stelsel**” beteken 'n stelsel van munisipale regering, wat daarvoor voorsiening maak, dat aangeleenthede wat van plaaslike belang vir wyke is hanteer word deur komitees, wat vir wyke ingestel word.

## Kategorie-A-munisipaliteite

2. In kategorie A mag die volgende soorte munisipaliteite in die Provinsie gevestig word:

- (a) 'n Munisipaliteit met 'n gesamentlike uitvoerende stelsel;
- (b) 'n munisipaliteit met 'n gesamentlike uitvoerende stelsel, gekombineerd met 'n subraad-deelnemende-stelsel;
- (c) 'n munisipaliteit met 'n gesamentlike uitvoerende stelsel, gekombineerd met 'n wyk-deelnemende-stelsel;
- (d) 'n munisipaliteit met 'n gesamentlike uitvoerende stelsel, gekombineerd met 'n subraad en 'n wyk-deelnemende-stelsel;
- (e) 'n munisipaliteit met 'n burgemeesters-uitvoerende-stelsel;
- (f) 'n munisipaliteit met 'n burgemeesters-uitvoerende-stelsel, gekombineerd met 'n subraad-deelnemende stelsel;
- (g) 'n munisipaliteit met 'n burgemeesters-uitvoerende-stelsel, gekombineerd met 'n wyk-deelnemende-stelsel; en
- (h) 'n munisipaliteit met 'n burgemeesters-uitvoerende-stelsel, gekombineerd met 'n subraad en 'n wyk-deelnemende-stelsel.

### **Kategorie-B-munisipaliteite**

3. In kategorie B mag die volgende soorte munisipaliteite in die Provinsie gevestig word:
- (a) 'n Munisipaliteit met 'n gesamentlike uitvoerende stelsel;
  - (b) 'n munisipaliteit met 'n gesamentlike uitvoerende stelsel, gekombineerd met 'n wyk-deelnemende-stelsel;
  - (c) 'n munisipaliteit met 'n burgemeesters-uitvoerende-stelsel;
  - (d) 'n munisipaliteit met 'n burgemeesters-uitvoerende-stelsel, gekombineerd met 'n wyk-deelnemende-stelsel;
  - (e) 'n munisipaliteit met 'n volle raad-uitvoerende-stelsel; en
  - (f) 'n munisipaliteit met 'n volle raad-uitvoerende-stelsel, gekombineerd met 'n wyk-deelnemende-stelsel.

### **Kategorie-C-munisipaliteite**

4. In kategorie C mag die volgende soorte munisipaliteite in die Provinsie gevestig word:
- (a) 'n Munisipaliteit met 'n gesamentlike uitvoerende stelsel;
  - (b) 'n munisipaliteit met 'n burgemeesters-uitvoerende-stelsel; en
  - (c) 'n munisipaliteit met 'n volle raad-uitvoerende-stelsel.
