

# PREMIER'S NOTICE

It is hereby notified that the Premier has assented to the following Act which is hereby published for general information:

No. 1 of 2000: Gauteng Finance Management Supplementary Act, 2000

# **ACT**

To give effect to certain provisions of the Public Finance Management Act, 1999, in the Province; to repeal the Provincial Exchequer Act, 1994 and to provide for matters in connection therewith

(English text signed by the Premier) (Assented to on 2 June 2000)

E IT ENACTED BY the Provincial Legislature of Gauteng, as follows—

#### **Definitions**

1. In this Act, unless the context otherwise indicates—

"the Act" means the Public Finance Management Act, 1999 (Act No. 1 of 1999).

## **Direct charges**

- **2.** The following payments from the Provincial Revenue Fund are direct charges against the Provincial Revenue Fund:
  - (a) transfers in terms of section 23(3)(a) of the Act;
  - (b) payments in terms of section 24(1)(b) and (c) of the Act;
  - (c) expenditure in terms of section 25(1) of the Act; and
  - (d) any utilization of savings in terms of section 43(1) of the Act.

### Transitional provision

3. The Provincial financial regulations and treasury instructions made or issued under the Provincial Exchequer Act, 1994 (Act No. 1 of 1994), remain in force, in so far as it is consistent with the Act, until the National Treasury issues regulations or instructions under section 76 of the Act.

# Repeal of legislation

4. The Provincial Exchequer Act, 1994 (Act No. 1 of 1994), is hereby repealed.

### Short title and commencement

**5.** This Act is called the Gauteng Finance Management Supplementary Act, 2000, and shall be regarded to have taken effect on 1 April 2000.
