



NOTICE 8705 OF 2000 COMMENCEMENT OF GAUTENG REGULATIONS ON SPECIAL PROCEDURES FOR LEGALISATION

I, Member of the Executive Council responsible for Public Transport, Roads and Works hereby under section 41 of the National Land Transport Transition Act, 2000 (Act No. 22 of 2000), fix 6 December 2000 as the date on which the regulations in the Schedule will come into operation.

GAUTENG REGULATIONS ON SPECIAL PROCEDURES FOR LEGALISATION

The Member of the Executive Council responsible for Public Transport, Roads and Works has under section 41 of the National Land Transport Transition Act, 2000 (Act No. 22 of 2000), made the regulations in the Schedule.

Definitions

1. In these regulations, unless the context indicates otherwise, a word or expression which is defined in the Act has the same meaning in these regulations, and in addition—

30434 Person 1

"board" means the Gauteng Transport Permit Board established in terms of section 2 of the Gauteng Interim Road Transport Act, 1998 (Act No. 2 of 1998) and as contemplated in Chapter 2, Part 8 of the Act; "the Act" means the National Land Transport Transition Act, 2000 (Act No. 22 of 2000).

Criteria for special procedures for legalisation

- **2.** Subject to regulation 5, the board must grant an operating licence authorising minibus taxi-type services to a public transport operator-
 - (a) as prescribed in section 41(1) of the Act; and
 - (b) who has applied in terms of a previous law to the Registrar for registration as a member of an association on or before 30 June 1997.

Application form for special legalisation

3. Subject to regulation 12, applications for legalisation in terms of section 41 of the Act must be lodged with the board on the form prescribed in Annexure A.

Issue of interim operating licence

4. Applicants who qualify in terms of regulation 2 must be issued with an interim operating licence in the format prescribed in Annexure B, which shall be valid for six months from the date of issue thereof.

Board may refuse to grant, or may withdraw or suspend interim operating licence in certain circumstances

- 5. The board may—
- (a) refuse to grant such an interim operating licence where the holder thereof has been convicted of an offence which the board regards as relevant and serious enough to justify such refusal; and

(b) withdraw or suspend such an interim operating licence in the circumstances contemplated in section 38(1) or (3) of the Gauteng Interim Minibus Taxi-Type Services Act, 1997 (Act No. 11 of 1997), in which case subsection (2) of that section shall apply.

Time limit for applications

6. The board may not accept any application for special legalisation under regulation 2 after 31 January 2001.

Submission of applications to planning authorities

7. Within seven days of receipt of an application under regulation 2, the board must submit it to the relevant planning authority for information and comment as contemplated in section 41(2)(a)(v) of the Act.

Fees

8. An application under regulation 2 must be accompanied by a non-refundable fee of R200, except for applications contemplated in regulation 12, where no fee shall be payable.

Moratorium on the granting of new operating licences

9. The board may not grant any new operating licences authorising minibus taxi-type services, except those contemplated in section 41(1) of the Act and these regulations, until a date to be determined by the MEC, in consultation with the Minister, and published in the *Provincial Gazette*, unless the MEC grants exemptions from this requirement in respect of specific routes on advice from the relevant planning authority.

Verification of details

10. (1) The Registrar must by written notice delivered by hand or sent by registered post, or by notice in the *Provincial Gazette* require all persons who have applied for legalisation in terms of regulation 2 to bring the relevant vehicle or vehicles to a venue stated in the notice on a date and at a time so stated to enable details of such vehicle or vehicles to be verified for the purposes of the application.

- (2) The Registrar may by written notice delivered by hand or sent by registered post, or by a notice published in the *Provincial Gazette*, require such an applicant or an official authorised by the relevant association to appear before the Registrar to confirm and verify the relevant route details as contemplated in section 41(2)(iv) of the Act.
- (3) The board may refuse to consider an application where the applicant has failed to comply with a notice under sub-regulation (1) or (2).

Routes

11. The board may not grant an interim operating licence under these regulations for a route that has not been specifically verified under regulation 10(2), and the board may not accept for that purpose any blanket route verifications.

Persons who have already applied for permits

- **12.** (1) Where a person has already applied for a permit before the date of commencement of the Act, he or she need not re-apply if the application form submitted with such former application substantially complies with the form set out in Annexure A, provided that the board may request the applicant to verify or update the information submitted with such application.
- (2) The board may refuse to consider an application where the applicant has not complied with a request under sub-regulation (1), or has not complied therewith to the satisfaction of the board.

Short title

13. These regulations shall be known as the Gauteng Regulations on Special Procedures for Legalisation, 2000.




