



### NOTICE 2220 OF 2003

#### CITY OF JOHANNESBURG

#### REMOVAL OF RESTRICTION ACT, 1996 (Act No 3 of 1996)

It is hereby notified in terms of section 6 (8) of the Removal of Restriction Act, 1996, that the City of Johannesburg has approved that;

- 1) conditions A(a), B(l), in Deed of Transfer T80835/1993 in respect Remaining Extent of Erf 249 Edenburg, conditions 1(c), (k), (m) and (n) in Deed of Transfer T80833/1993 in respect of Portion 1 of erf 42 Woodmead, conditions (c), (k), (m) and (n), in deed of transfer T80834/1993 in respect of Re of erf 42, Woodmead, conditions B(c), C(a), C(c) and F(b) in Deed of Transfer T22484/1966 in respect of Re of Erf 43 Woodmead, to be removed; and
- 2) Sandton Town-Planning Scheme, 1980, be amended by the rezoning of Portion 1 , part of portion 2 and portion 3 of erf 205 and remainder of erf 205 Edenburg, and Remainder of erf 249, Edenburg , portion 1 and remainder of erf 42, Woodmead and remainder of erf 43 ,Woodmead, from " Residential 1" to " Residential 2, ", subject to certain conditions, which amendment scheme will be known as Sandton Amendment Scheme 0152E as indicated on the approved application which are open for inspection at the office of the Executive Director: Development Planning, Transportation and Environment, 158 Loveday street, Braamfontein , 8<sup>th</sup> floor, A Block , Civic Centre
