NOTICE 935 OF 2007

GAUTENG PROVINCIAL GOVERNMENT

DEPARTMENT OF ECONOMIC AFFAIRS REGULATIONS IN TERMS OF SECTION 84 OF THE GAUTENG GAMBLING ACT, 1995 (ACT NO. 4 OF 1995)

I, Paul Mashatile, Member of the Executive Council responsible for Economic Affairs have, under Section 84 of the Gauteng Gambling Act, 1995 (Act No 4 of 1995), made the amendment Regulations set out in the Schedule.

The Regulations take effect from 1 April 2007.
