SEVENTH AMENDMENT OF THE GAUTENG ROAD TRAFFIC REGULATIONS, 2007

The Member of the Executive Council responsible for road traffic regulation in the Province has under section 25 of the Gauteng Provincial Road Traffic Act, 1997 (Act No. 10 of 1997), made the Regulations in the Schedule.

SCHEDULE

Definition

1. Short title and commencement

5. These Regulations are called the Seventh Amendment of the Gauteng Road Traffic Regulations, 2001, and come into operation on 01 April 2007.
