An invitation is hereby made in terms of section 49(l)(a)(ii) read together with section 78(2) of the Act that any owner of property or other person who so desires should lodge an objection with the municipal manager in respect of any matter reflected in, or omitted from, the supplementary valuation roll within the above-mentioned period. Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the supplementary valuation roll as such. The form for the lodging of an objection is obtainable from the listed Municipal Offices, or website www.ekurhuleni.com. Alternatively, an e-mail with only the Account Number of the property in the subject line can be sent to objections@emmm.evaluations.co.za and the relevant objection form for that property will be sent electronically to such requester.

The completed objection forms must be returned **by hand** to any of the listed Municipal Offices. Kindly bring along your Section 49 notice when submitting your objection, as this will expedite the submission process.

No form of electronic submission will be accepted. CLOSING DATE FOR OBJECTIONS IS 16:00 ON TUESDAY 30 JUNE 2009. No late objections will be accepted.
