**LOCAL AUTHORITY NOTICE****LOCAL AUTHORITY NOTICE 636****KUNGWINI LOCAL MUNICIPALITY  
PERI-URBAN AREAS AMENDMENT SCHEME 544**

It is hereby notified in terms of the provisions of Section 57 (1) (a) of the Town Planning and Town Planning Ordinance, 1986 (Ordinance No 15 of 1986) that the Kungwini Local Municipality has approved the amendment of the Peri-Urban Areas Town Planning Scheme, 1975, being the rezoning of Erf 684, Tijger Vallei, from "Undetermined" to "Special for Institutional uses which may include a day hospital and a sub-acute hospital as well as facilities normally associated with a hospital such as a coffee shop, florist etc., subject to certain further conditions.

Map 3 and the scheme clauses of this amendment scheme are filed with the Senior Manager, Development Planning and Rural Development, Kungwini Local Municipality and are open to inspection during normal office hours.

This amendment is known as Peri-Urban Areas Amendment Scheme 544 and shall come into operation on the date of publication of this notice.
