DECLARATION OF SIX FOUNTAINS EXTENSION 4 TOWNSHIP AS AN APPROVED TOWNSHIP

In terms of Section 103 of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986), the Kungwini Local Municipality hereby declares the Township of **Six Fountains Extension 4** to be an approved township, subject to the conditions as set out in the Schedule hereto.

STATEMENT OF THE CONDITIONS UNDER WHICH THE APPLICATION MADE BY CROWMARSH PROPERTIES (PROPRIETARY) LIMITED, HEREINAFTER REFERRED TO AS THE APPLICANT, UNDER THE PROVISIONS OF CHAPTER III OF THE TOWN PLANNING AND TOWNSHIPS ORDINANCE, 1986 (ORDINANCE 15 OF 1986) FOR PERMISSION TO ESTABLISH A TOWNSHIP ON PORTION 157 (A PORTION OF PORTION 13) OF THE FARM ZWARTKOPPIES 364 REGISTRATION DIVISION JR, THE PROVINCE OF GAUTENG, HAS BEEN GRANTED

1. CONDITIONS OF ESTABLISHMENT (CONDITIONS WHICH WILL BE APPLICABLE TO THE APPROVED TOWNSHIP IN TERMS OF SECTION 103 OF ORDINANCE 15 OF 1986)

1.1 NAME

The name of the township shall be SIX FOUNTAINS EXTENSION 4.

1.2 DESIGN

The township shall consist of erven and streets as indicated on Plan S.G. No. 910/2007.

1.3 CONSOLIDATION

Erven 202 and 203 shall be consolidated on declaration of the township as an approved township.

1.4 ACCESS

No ingress from Provincial Road K69 to the township and no egress to Provincial Road K69 from the township shall be allowed.

1.5 RECEIVING AND DISPOSAL OF STORMWATER

The township owner shall arrange the stormwater drainage of the township in such a way as to fit in with that of K69 and he shall receive and dispose of the stormwater running off or being diverted from this road.

1.6 ERECTION OF FENCE OR OTHER PHYSICAL BARRIER

The township owner shall at his own expense erect a brick wall or security fence on property boundaries bordering on K69 to the satisfaction of the Head of Department of Public Transport, Roads and Works, Gauteng Provincial Government, as and when

required by him to do so, and the township owner shall maintain such brick wall or security fence in a good state of repair until such time as the erven in the township are transferred to ensuing landowners, after which the responsibility for the maintenance of such brick wall or security fence rests with the latter.

1.7 PROVISION OF ESSENTIAL ENGINEERING SERVICES

The applicant must make the necessary arrangements with the Kungwini Local Municipality and/or relevant service provider on behalf of the Kungwini Local Municipality regarding the provision of water, electricity, sanitation as well as the building of roads and stormwater drainage in the township and such services shall comply to the standards of the said Municipality;

PROVIDED THAT services reports and services agreements in respect of the provision and installation of internal as well as external essential engineering services to emanate from the said arrangements shall firstly be submitted by the applicant to representative Attorneys at Law as designated by Kungwini Local Municipality for evaluation and thereafter be submitted to Kungwini Local Municipality for approval.

1.8 ENDOWMENT

The applicant shall in terms of the provisions of Section 63(1)(b) of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986) not be liable for the payment of contributions in respect of the provision of open spaces or parks.

1.9 DISPOSAL OF EXISTING CONDITIONS OF TITLE

All erven shall be made subject to existing conditions and servitudes, where applicable, including entitlement to the right of way servitude over Portion 109 (Portion of Portion 13) of the farm Zwartkoppies No. 364 JR, The Province of Gauteng, as indicated by the figure ABCDEFGHJKItvwxyzA on Diagram SG No. 3625/1999, the latter property held by Deed of Transfer T 75046/99, as well as reservation of rights to minerals, but excluding:

1.9.1 The following conditions which do not affect the township or erven in the township:

1.9.1.1 "A. GEDEELTE 7 van die plaas ZWARTKOPPIES 364 JR, Die Provinsie van Gauteng (waarvan die gedeelte hiermee getranspoteer 'n deel vorm) is spesiaal onderworpe aan die volgende voorwaardes:

1.9.1.3 "C Further subject to a Servitude in favour of the local authority for municipal services as will more fully appear from Notarial Deed of Servitude No. K3083/1999S dated 23 June 1999."

1.9.2 The following servitude which affects the township and erven within:

1.9.2.1 "Die eiendom hierkragtens gehou is onderhewig aan 'n Kraglyn-serwituut, 31 meter wyd, ten gunste van die Stadsraad van Pretoria, soos meer volledig sal blyk uit Notariële Akte van Serwituut nr K145/93-S".

1.10 DEPROCLAMATION OF PUBLIC ROAD

Subject to approval of the authorised authority, the public road promulgated as per Administrator's Notice 1119 of 6 July 1983 may be deproclaimed insofar as it affects the township and erven within.

1.11 REMOVAL OF LITTER

The applicant shall at his own expense cause all litter within the township area to be removed to the satisfaction of Kungwini Local Municipality, if and when required to do so.

1.12 REMOVAL AND/OR REPLACEMENT OF ESKOM POWER LINES

Should it become necessary to remove and/or replace any existing power lines of Eskom as a result of the establishment of the township, the cost thereof shall be borne by the township owner.

1.13 REMOVAL AND/OR REPLACEMENT OF TELKOM SERVICES

Should it become necessary to remove and/or replace any existing Telkom services as a result of the establishment of the township, the cost thereof shall be borne by the township owner.

2. CONDITIONS OF TITLE

The erven mentioned below shall be subject to the conditions as indicated, laid down by the Kungwini Local Municipality in terms of the provisions of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986).

2.1 ALL ERVEN

- (a) The erf shall be subject to a servitude, 2 m wide, for municipal services (water, sewer, electricity and stormwater) (hereinafter referred to as "the services"), in favour of the local authority, along any two boundaries, except in respect of a street boundary.
- (b) No buildings or other structures may be erected within the aforesaid servitude area and no trees with large roots may be planted within the area of such servitude or within a distance of 2 m from it.
- (c) The local authority shall be entitled to temporarily deposit on the land adjoining the aforesaid servitude, any material it excavates during the laying, maintenance or removal of such services and other works which in its discretion it regards necessary, and furthermore the local authority shall be entitled to reasonable access to the said

property for the aforesaid purpose, subject to the provision that the local authority shall make good any damage caused during the laying, maintenance or removal of such services and other works.

2.2 REGISTRATION OF SERVITUDES

1. STIGTINGSVOORWAARDES (VOORWAARDES WAT VAN TOEPASSING SAL WEES OP DIE GOEDGEKEURDE DORP IN TERME VAN ARTIKEL 103 VAN ORDONNANSIE 15 VAN 1986)

1.1 NAAM

Die naam van die dorp is SIX FOUNTAINS UITBREIDING 4.

1.2 ONTWERP

Die dorp bestaan uit erwe en strate soos aangedui op Algemene Plan LG No. 910/2007.

1.3 KONSOLIDASIE

Erwe 202 en 203 sal gekonsolideer word op verklaring van die dorp tot 'n goedgekeurde dorp.

1.4 TOEGANG
