

NOTICE 456 OF 2012

DEPOSIT OF COMPENSATION WITH THE MASTER: UNIT 8 GLENFIELD COURT SS111/1984.

The Member of the Executive Council ("MEC") responsible for provincial roads in the Province of Gauteng acting in terms of section 19(1) of the Gauteng Transport Infrastructure Act, 2001 (Act 8 of 2001) "the Act" expropriated sectional title unit number 8 (ST26040/2007) in the sectional title scheme known as Glenfield Court registration number SS111/1984 situated in Rhodesfield on 10 October 2007 for the construction of the Gautrain Rapid Rail Link.

As the registered owner, Mr. Bruce Ndlovu, died before compensation could be paid, the MEC is unable to determine to whom the compensation must be paid, a notice in terms of section 35(1) of the Act is hereby published to request his dependants or close relatives to liaise with the Department of Roads and Transport within 14 days after the publication of this notice in order to finalise the compensation payable under the Act. Failing to respond within the stipulated period, the compensation will be paid to the Master of the High Court having jurisdiction, after which the MEC shall cease to be liable for the payment of the amount deposited.
