GENERAL NOTICE

NOTICE 1251 OF 2012 AMENDMENT OF GENERAL PLAN IRENE EXTENSION 60

In terms of the provisions of the Development Facilitation Act, 1995, read with the requirements of the Deeds Registries Act, 1969, the Gauteng Development Tribunal has approved the amendment of General Plan 9791/2004 of Irene Extension 60 and, in so doing has amended the conditions of establishment originally published under the then Notice 799, dated 21 June 2006 under Reference 13/2/Irene X60 (1445C) as set out in the schedule hereto.

SCHEDULE

Amendments to the Conditions under which Irene Extension 60 Township was declared to be an approved township.

Irene Extension 60 Township as depicted on General Plan SG Number 9791/2004 is hereby amended by denoting of General Plan an area of approximately 7324m² as Erf 4308, formerly a portion of Mezereon Crescent, as reflected on SG Diagram 820/2011.

The amendment of the Irene Extension 60 Township results in the following amendments to the existing conditions of establishment:

1. With regard to Conditions 1 and 2 namely Conditions of Establishment and Conditions of Title respectively, such conditions will henceforth apply to Erf 4308 to the extent that such conditions may be relevant.
2. Save for the aforesaid, the original conditions of establishment published under Notice 799 on 21 June 2006 shall remain unchanged.
