FIXING OF A BUS RAPID TRANSIT STATION: ARCADIA STREET BETWEEN HILDA AND GROSVENOR STREETS, HATFIELD

Notice is hereby given, in terms of section 65 *bis* (2) of the Local Governance Ordinance, 1939 that the City of Tshwane Metropolitan Municipality intends to fix a Bus Rapid transit station on the median island in Arcadia Street between Hilda and Grosvenor Streets, Hatfield as from 19 June 2012 which will form part of the bus rapid transit system to be instituted.
