

REMUNERATION OF PUBLIC OFFICE BEARERS ACT, 1998 (ACT NO. 20 OF 1998)

DETERMINATION OF SALARIES AND ALLOWANCES OF MEMBERS OF THE EXECUTIVE COUNCIL AND THE DIFFERENT MEMBERS OF THE PROVINCIAL LEGISLATURE: GAUTENG PROVINCE

- I, Nomvula Paula Mokonyane, Premier of the Gauteng Province, under section 6(3)(a) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) ("the Remuneration Act"), read with Proclamation by the President No. 44 of 2012, published in Government Gazette No. 35653 on 03 September 2012 ("the Proclamation"), hereby determine that the total remuneration packages of the positions of office bearers in Column 3 of the Schedule shall be as set out in Column 4 of the Schedule with effect from 01 April 2012, subject to the provisions of sections 6(2) to (7) of the Remuneration Act, and the terms and conditions set out herein.
- 2. The total remuneration packages referred to in 1 above include the following elements:
- a basic salary component equal to 60% of the total package, which is pensionable;
- an amount of R120 000 per annum, which is an amount to which section 8(1)(d) of the Income Tax Act, 1962 applies. This amount is included in the basic salary component;
- an employer's pension benefit contribution equal to 22.5% of pensionable salary; and
- a flexible portion for the remaining amount of the total remuneration.
- 3. The remaining 32% of the recommended employer's pension benefit contribution will not form part of the total remuneration package. The State will contribute the cash on an annual basis into the pension fund.
