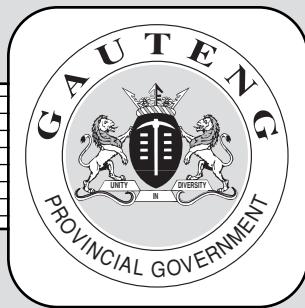

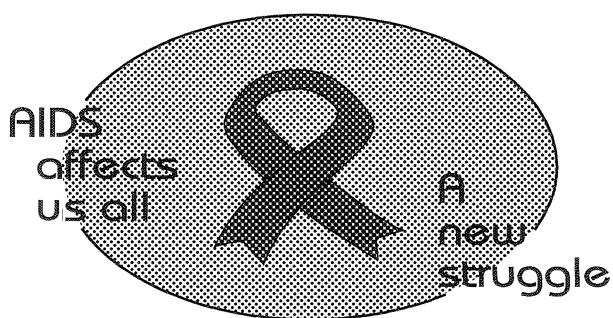

NOTICE 2561 OF 2012

GAUTENG REMOVAL OF RESTRICTION ACT, 1996
BEDFORDVIEW AMENDMENT SCHEME 1094

ERF 43 ESSEXWOLD

It is hereby notified in terms of Section 6(8) of the Gauteng Removal of Restrictions Act, 1996 (Act 3 of 1996) as amended, that the Ekurhuleni Metropolitan Municipality has approved the simultaneous removal of restrictive conditions (d) to (q) in Deed of Transfer F610/1963 and the amendment of the Bedfordview Town Planning Scheme, 1995, by the rezoning of Erf 43, Essexwold from "Residential 1" with a density of one dwelling per erf to "Residential 1" with a density of one dwelling per 1500m² for the Remainder and one dwelling per 1000m² for the balance of the site, subject to certain conditions.

The Map 3 and Scheme Clauses of the Amendment Scheme are filed with the Area Manager: City Planning, Edenvale Customer Care Centre, corner of Van Riebeeck Avenue and Hendrik Potgieter Street, Edenvale and are open for inspection at all reasonable times.

The Amendment is known as Bedfordview Amendment Scheme 1094.
