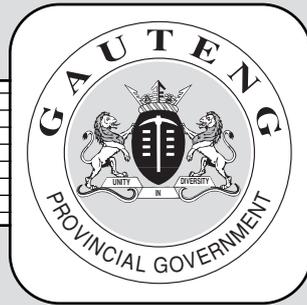



GOVERNMENT: MUNICIPAL PROPERTY RATES ACT, ACT NO. 6 OF 2004 READ  
WITH THE LOCAL GOVERNMENT: MUNICIPAL FINANCE MANAGEMENT ACT, ACT  
56 OF 2003**

Notice is hereby given in terms of section 75 A (3) of the Local Government: Municipal Systems Act, Act No. 32 of 2000 that the 2013/2014 Budget, Service Tariffs and Rates Levies of Midvaal Local Municipality were approved on 28 May 2013.

1. The approved service tariffs and rates levies will into operation on 1 July 2013.
2. In terms of the provisions of Section 14(2) of the Local Government: Municipal Property Rates Act, Act No. 6 of 2004, notice is also hereby given that the approved rates levies for the 2013/2014 financial year are as follows:

Business	-	R0.01222/R (the maximum levy be capped at R148 000 per month)
Residential	-	R0.01212/R minus 46.5%
Agricultural	> - 16 hectare	R0.00159/R
	< - 16 hectare	R0.00303/R

3. The resolutions regarding the service tariffs and rates levies are available at the Municipality's head office (Rates Section), satellite offices and libraries for public inspection during office hours as well as on the official website of the municipality, [www.midvaal.gov.za](http://www.midvaal.gov.za).
4. The resolution of Council will also be duly promulgated by publishing the resolution in the Provincial Gazette.
