

CORRECTION NOTICE

The Administrator hereby, in terms of the provisions of the Town-planning and Townships Ordinance, 1965, (Ordinance 25 of 1965) the afrikaans and the english version of General Notice No. 1259/2009 (published as Extraordinary Notice No. 166, in the Gauteng Provincial Gazette on 27 July 2009), is hereby amended and corrected in the following manner:

- 1. Renumber the preamble of clause 3 "3.CONDITIONS OF TITLE" to "2. CONDITIONS OF TITLE"
- 2. Delete Clause 3.(3)(i) and renumber subsequent clause; and
- 3. Substitute clause 1.(4)(c) with the following new clause 1(4)(c)(i) and (ii):
 - (c) The following servitude which affects Erf 517 in the township only:
 - (i) "SUBJECT subject to a right granted to the TOWN COUNCIL of BOKSBURG to convey electricity over the property together with ancillary rights as will more fully appear from Notarial Deed K 1225/1962S"
 - (ii) "SUBJECT to a Right of way Servitude, indicated by the figures A B C D E F G H J on diagram S.G.No. 8963/2008, as will more fully appear from Notarial Deed of Servitude K 2986/2009S.
